FOREWORD WILDFIRE ACTIVITY STATISTICS

The California Department of Forestry and Fire Protection (CAL FIRE) provides the annual Wildfire Activity Statistics report. Although it contains other information, this report is primarily a statistical record of wildfire incidents responded to by CAL FIRE personnel and resources, performing the State/CAL FIRE mission, using State funding within CAL FIRE Direct Protection Area (DPA).

The existing overall fire protection system involving CAL FIRE and California is rather complex. Several technical terms are utilized, and the use of fire statistics typically presupposes some understanding of the overall framework. A description of this framework can be found at (https://www.fire.ca.gov/what-we-do/fire-protection), and in the Glossary of terms at the end of this document.

The first Forest Fire Summary (RED BOOK) was published in 1943 and has continued to this date. Prior to 1989, data and statistics were tabulated manually; today, statistics are derived from an automated database. CAL FIRE began electronically entering incident data into the Emergency Activity Reporting System (EARS) on July 1, 1989. Starting at the end of 2006, CAL FIRE began reporting incidents using a web-based subscription service called California All Incident Reporting System (CAIRS). In 2019, CAL FIRE began reporting incidents using a web-based subscription service called CAL FIRE Incident Reporting System (CALFIRS). This data is imported into the California Incident Data and Statistics (CalStats) database by CAL FIRE staff and the data is uploaded periodically to the National Database maintained by the United States Fire Administration (USFA). Due to the changes in data collection, methods, and systems over the years, information may not always be comparable, and data may be of differing accuracy or completeness.

Throughout this report, the statistics are displayed by **who** provides the wildfire protection. Forces include CAL FIRE personnel and resources, CAL FIRE employees working under a local government agreement, Contract County personnel, and federal firefighting resources. The second part of the statistical reporting is **where** the protection is provided. Areas are categorized as State Responsibility Area (SRA) or DPA.

SRA is State and privately-owned forest, watershed, and rangeland for which the primary financial responsibility of preventing and suppressing wildfires rests with the State (Map 1).

The term "Direct Protection Area" is applied to indicate when a particular fire protection organization has the primary responsibility for responding to an uncontrolled fire and for directing the suppression activity. Thus, in addition to lands in SRA, CAL FIRE may have "direct protection" responsibility on lands in federal jurisdiction. At the same time, federal agencies, such as the U.S. Forest Service, may have "direct protection" responsibility for lands in SRA and federal areas for which CAL FIRE has "direct protection" responsibility for fire protection responses are depicted on Map 2.

The State contracts with six counties to provide protection of SRA within their boundaries. These counties [Kern, Los Angeles, Marin, Orange, Santa Barbara, and Ventura] are referred to as Contract Counties.

CAL FIRE provides full-service fire protection to over 100 local government cooperators through agreements with counties, cities, fire districts, special districts, and service areas. Wildfire statistics associated with incidents where local government reimburses CAL FIRE for services are displayed in Table 1.

This report also includes a statewide summary of California wildfires (Table 1) and a listing of wildfires over three hundred acres for all wildfire agencies (Tables 5 and 6). The statistical information in this report is gathered from data in the previously defined CALFIRS and Incident Status Summaries (ICS-209) on the Integrated National Application Portal (iNAP) website: https://famauth.wildfire.gov/index.html.

This report is compiled by the CAL FIRE – Office of the State Fire Marshal's (OSFM) California Incident Data and Statistics (CalStats) Program. The OSFM not only manages CAL FIRE's incident reporting system (CALFIRS), but is also charged with collecting, analyzing, and distributing statistical information reported by all California fire departments throughout the state. This effort is accomplished using the National Fire Incident Reporting System (NFIRS) managed by the United States Fire Administration (USFA).

2024 STATEWIDE FIRE SUMMARY

During 2024, wildfire firefighting agencies responded to 8,110 fires that burned 1,077,711 acres. For wildfire agencies, this represents a 10% increase in the number of fires and a 224% increase in acres burned from 2023. CAL FIRE, through State funded and local government contracts, as well as Contract Counties, reported 6,928 wildfire incidents that burned 588,782 acres, which represents a 13% increase in fires and a 1,104% increase in acres burned from 2023.

STATE RESPONSIBILITY AREA (SRA)



CAL FIRE DIRECT PROTECTION AREA (SRA)








Graphic Figure 1. Percent of CAL FIRE SRA Fires by Cause




Graphic Figure 2. CAL FIRE SRA Number of Acres Burned — 2015-2024




Graphic Figure 3. CAL FIRE SRA Number of Fires — 2015-2024




Graphic Figure 4. Number of CAL FIRE SRA Fires by Cause — 2024, 2023, and 5 Year Average





Graphic Figure 5. CAL FIRE SRA Fires and Acres — 2024, 2023, and 5 Year Average







Graphic Figure 6. CAL FIRE SRA Fires and Acres by Region — 2024, 2023, and 5 Year Average






Graphic Figure 7. CAL FIRE SRA Number of Arson Fires and Acres — 2015-2024







Graphic Figure 8. CAL FIRE SRA Number of Fires by Time of the Day




Graphic Figure 9. CAL FIRE SRA Number of Fires and Acres Burned by Month

This information is gathered from the CAL FIRE Damage Inspection (DINS) reports, the CAL FIRE Incident Reporting System (CALFIRS) reports, and the Incident Status Summaries (ICS-209) on the Integrated National Application Portal (iNAP) website.

Structures Destroyed = Residence, commercial property, outbuilding, or other structure that is declared lost.

2007 includes the Witch Fire, which destroyed 1,650 structures.

2015 includes the Valley Fire, which destroyed 1,958 structures, and the Butte Fire, which destroyed 965 structures.

2017 includes the Thomas Fire, which destroyed 1,060 structures, as well as the Mendocino Lake Complex, Central LNU Complex, Southern LNU Complex and NEU Wind Complex incidents, which destroyed a combined total of 8,886 structures. These complex incidents were comprised of the Redwood Valley, Sulphur, Tubbs, Nuns, Pocket, Atlas, Cascade, La Porte, McCourtney, and Lobo fires.

2018 includes the Carr, Camp, and Woolsey fires, which destroyed 1,614 structures, 18,804 structures, and 1,185 structures, respectively.

2020 includes the group of incidents known as the "2020 Fire Siege," which destroyed a combined total of over 9,000 structures.

2021 includes the Dixie and Caldor fires, which destroyed 1,311 structures and 1,003 structures, respectively.

GLOSSARY

ARSON – To unlawfully and intentionally damage, or attempt to damage, any real or personal property by fire or incendiary device.

CAMPFIRE – See "Recreation and Ceremony."

CONTRACT COUNTIES – PRC §4133 and Section 55607 of the Government Code permit the CAL FIRE Director to contract with counties for protection of State Responsibility Area (SRA). In California, CAL FIRE contracts with six counties to provide fire-protection and prevention services in SRA. The counties of Kern, Los Angeles, Marin, Orange, Santa Barbara, and Ventura are Contract Counties.

DEBRIS AND OPEN BURNING (DOB) – Outside fire for vegetation, waste, or trash disposal. *Formerly "Debris Burning."*

DIRECT PROTECTION AREA (DPA) – The area for which a particular fire protection organization has the primary responsibility by law or contract for attacking an uncontrolled fire and directing the suppression activities.

DOLLAR DAMAGE – Estimates of the total property and contents dollar loss in terms of replacement in like kind and quantity. This estimation of the dollar loss includes property and contents damaged by fire, smoke, water, and overhaul. This does not include suppression costs or indirect loss, such as business interruption.

ELECTRICAL POWER – See "Power Generation/Transmission/Distribution."

EQUIPMENT USE – Fire ignited by the use or failure of mechanical or electrical equipment. Does not include fire ignited by powerlines.

FOREST FIRE – A fire burning uncontrolled on land covered entirely or in part by timber, brush, grass, grain, or other flammable vegetation.

LIGHTNING - See "Natural."

LOCAL GOVERNMENT – A fire department, especially of a municipal government, whose purpose is preventing and extinguishing fires.

LOCAL GOVERNMENT CONTRACT – PRC §4142 allows CAL FIRE to contract with local governments to provide fire protection and emergency services through the administration of over 100 cooperative fire protection agreements in the State.

MISCELLANEOUS - See "Other."

MISUSE OF FIRE BY A MINOR (MFM) – See "Misuse of Fire by a Minor." Fire ignited unintentionally by children while playing or experimenting with fire or fire-causing devices.

NATURAL – Fire ignited by a natural occurrence, including lightning discharge and volcano. *Lightning is now a subcategory of this cause.*

OTHER – Fire ignited by events or activities that are not classified as arson, debris and open burning, equipment, misuse of fire by a minor, natural, power generation/transmission/distribution, railroad operations and maintenance, recreation and ceremony, smoking, vehicle, or undetermined. *Formerly "Miscellaneous."*

OUTBUILDING – A building that is separate from a main building and located on the same property.

PLAYING WITH FIRE (PWF) - See "Misuse of Fire by a Minor."

POWER GENERATION/TRANSMISSION/DISTRIBUTION (PGTD) – Fire ignited by electrical power distribution or transmission. *Formerly "Electrical Power."*

RAILROAD OPERATIONS AND MAINTENANCE (RR) – Fire ignited by rail transport vehicles or fire ignited on or near railroad right-of-way. *Formerly "Railroad."*

RECREATION AND CEREMONY (RC) – Outside fire used for cooking, warmth, lighting, ceremonial, or aesthetic purposes. *Formerly "Campfire."*

SMOKING – Fires ignited by smoking tobacco or other smoking material; includes matches, lighters, or other heat sources used in smoking.

STATE RESPONSIBILITY AREA (SRA) – Areas of the State in which the financial responsibility of preventing and suppressing fires has been determined by the State Board of Forestry and Fire Protection, to be primarily the responsibility of the State, PRC §4102.

STRUCTURE – An assembly of materials forming a construction for occupancy or use to serve a specific purpose, includes enclosed building, fixed portable building, or mobile home.

UNCONTROLLED FIRE – Any fire which threatens to destroy life, property, or resources and either: (1) is unattended by any person; (2) is attended by persons unable to prevent its unrestricted spread; and (3) is burning with such velocity or intensity that it could not be readily controlled with ordinary tools available to persons at the fire scene.

UNDETERMINED – A fire that has been investigated and has insufficient information to classify further, a fire that is under investigation, or a fire that has not yet been investigated.

VEHICLE – Fire ignited by mobile property which include: Passenger automobile, bus, school bus, off road recreational, motor home, travel trailer, camping trailer, mobile home or office designed to be towed, motorcycle or scooter.

WILDFIRE – Any uncontrolled fire spreading through vegetative fuels that threatens to destroy life, property, or resources, PRC §4103 and 4104.

WILDLAND-URBAN INTERFACE – A geographical area identified by the State as a "Fire Hazard Severity Zone" in accordance with the PRC §4201 through 4204 and Government Code §51175 through 51189, or other areas designed to be at a significant risk from wildfires.
