**May 9, 2025****Public Notice****Seasonal Listing of Open and Closed Roads and Campgrounds - Dry Season 2025**

As of **Friday, May 23, 2025**, the following Road and Campground openings and closures within Jackson Demonstration State Forest (JDSF) will be in effect:

The following **ROADS** (and associated spurs) will be **CLOSED** to motor vehicles during the dry season of 2025:

50, 51, 70, 80, 90, 100, 110, 111, 120, 150, 202, 203, 204, 210, 213, 220, 231, 233, 234, 251, 252, 253, 254, 255, 256, 300 (east of Rd 332), 305, 308, 309, 311, 315, 321, 322, 323, 324, 325, and spurs, 359, 360 (between Teachers Campground and 1000), 361, 362, 363, 370 and spurs, 380, 381, 390, 400, 410, 420, 430, 440, 445 and spurs, 450, 452, 455, 456, 460, 462, 463, 490, 508, 510, 511, 512, 515, 516, 520, 530, 533, 550, 560, 561, 600, 620, 630, 640, 669, 690, 705, 730, 740, 750, 760, 770, 910, 1020, 1021, and 1040. Some roads above may be temporarily opened for firewood cutting.

* Roads 250 and 350 leading into Camp 1 will be **OPEN** until the start of road work and 720 **CLOSED** until road work is completed. All work involves culvert replacements. Road 100 will be closed due to trash dumping.

The road closures prohibit the use of all unauthorized motorized vehicles, including motorcycles, and ATVs. Closed roads not involving road work may still be used for hiking, bicycling, and horseback riding except where closed to any public access for safety concerns. **Note: Only vehicles properly licensed for highway use may be operated within JDSF. Off-road motorcycles and ATVs are not allowed.**

The following **ROADS** will generally be **OPEN** to motor vehicles during the dry season of 2025:

200, 230, 240, 250*, 300 (west of Rd 332), 330, 332, 350*, 360 (south of Teachers Campground) 500, 700, 720*, 800, 810, 830, 900, 920, 930, 1000 [west of Rd 200 & between Rd 200 & Rd 1070, (within JDSF) & east of Rd 200] and 1070.

Some roads may be temporarily closed due to hazardous conditions, timber operations, road upgrades or to protect natural resources).

Please do not drive on roads that are wet and have soft surfaces, even if they are not formally closed. It is not safe to drive on roads with slippery surfaces. Please help us protect your forest resources.

The following **CAMPsites & DAY USE AREAS** will be **OPEN/CLOSED**:

JDSF campgrounds, including Camp 1, Dunlap, Big River, and Horse Camp, will be **OPEN** on May 23, 2025. Camp 1 Campgrounds will be temporarily **CLOSED** mid to late summer to replace culverts along Road 350. Timing will depend on the contractor's availability.

Note: Roads or campsites may be temporarily opened or closed at any time for maintenance or repairs, for public health and safety reasons, timber operations, or to protect natural resources.
