




\*\*\*\*The Field Tour portion of the meeting will be accessed via JDSF Road 210. The tour will occur on gravel and dirt roads that only 4WD vehicles can access. Vehicle access may be further limited by saturated soil conditions. The tour will involve approximately 2 miles of walking and 200 feet of elevation change, mostly on roads. #### Driving Directions to Adaptive Management Experiment (AMEX) THP Tour, Fort Bragg, CA 95437.

From Highway 1 in Fort Bragg, drive east on Highway 20 for approximately 17 miles. Turn right into Camp 20 Day Use Area on the south side of the Highway. Tour will convene in the Day Use Area. Walking route will be Road 210 to the intersection with Road 213 on the ridge. Please plan to walk the tour route if able. Please see the ADA notice if you need assistance. 
