<p>All new applicants for a type A, B &amp; C Timber Operator License must register for <u>one</u> of the 2-days LTO class through the above listed venues. The class size will vary depending on the venue. The venue will send you a receipt, a copy of their refund policy in the event that you need to cancel, a map, and a list of local accommodations.</p> <p>The class will be held for two (2) eight-hour days (8:00am – 5:00pm). To receive a certificate of completion, <b><u>attendance at BOTH class sessions for the ENTIRE eight-hour duration is MANDATORY.</u></b> Refreshments will not be provided (bring your own lunch). Class materials will be distributed in class; please bring a 3-ring binder, a pen/pencil, a highlighter, and note paper.</p> <p>Scheduled dates are subject to change. In the event of a schedule change, students will be notified and will remain registered unless a cancellation.</p> <p><b>PLEASE NOTE: Completion of the training class DOES NOT mean you have a valid Timber Operator License. To complete the application process, you must submit a completed application (original, signed in ink) within one year (12 months) of taking the class. A license will only be issued once ALL requirements are met.</b></p>
