All new applicants for a type A, B & C Timber Operator License must register for one of the 2-days LTO class through the above listed venues. The class size will vary depending on the venue. The venue will send you a receipt, a copy of their refund policy if you need to cancel, a map, and a list of local accommodations.

The class will be held for two (2) eight-hour days (8:00am – 5:00pm). To receive a certificate of completion, **attendance at BOTH class sessions for the ENTIRE eight-hour duration is MANDATORY**. Refreshments will not be provided (bring your own lunch). Class materials will be distributed in class; please bring a 3-ring binder, a pen/pencil, a highlighter, and note paper.

Scheduled dates are subject to change. In the event of a schedule change, students will be notified and will remain registered unless a cancellation.

**PLEASE NOTE:** Completion of the training class **DOES NOT** mean you have a valid Timber Operator License. To complete the application process, you must submit a completed application (original, signed in ink) within one year (12 months) of taking the class. A license will only be issued once **ALL** requirements are met.
