Background Information:


CAL FIRE Office of the State Fire Marshal's (OSFM) Automatic Extinguishing Systems Program plays a critical role in the professionalism in the Automatic Extinguisher Industry. The Office of the State Fire Marshal (OSFM) certifies the qualified individuals who install and service these systems. The AES program includes certifications for fire sprinkler pipe fitters, engineered and pre-engineered testing, fire sprinkler testing and fire pump testing. This ensures that system that provide life safety, are installed and service properly and will function correctly and protect the citizens of California.

The fees for the AES program go into the Licensing and Certification Fund. Health and Safety Code Section 13137 governs the use of the State Fire Marshal Licensing and Certification Fund. Section 13137 specifies that the fees may not exceed the actual cost of administrating the OSFM's Licensing and Certification programs, and fees must be used for the benefit of the same group they are collected from.

Analysis/Summary of Issue:

The Automatic Extinguishing System (AES) program is a self-funded. The current levels of funds from the current fee are insufficient to sustain the Automatic Extinguishing Systems Program without incurring a deficit.

The proposed fee increase for the Fire Sprinkler Fitter Certification would be a 10% increase. These fees were set in 2017, and in the last seven years there has been an increase in cost due to inflation. The fee increases with an increase of 1600 certified fitters will be needed to recover the program costs.

Potential Industry Impacts:

The proposed regulations will impose cost impacts that a directly affected business would incur in reasonable compliance with the proposed action. There are approximately 2,757 businesses licensed through this program, including Type 1, Type 2, Type L, and C-16 business license holders. There are currently 4,472 certified Fire Sprinkler Fitters in different classifications. The direct cost for the certified Fire Sprinkler Fitters is \$89,440. The total direct cost to all of the affected companies and individuals is \$179,092.
