Conducted a walk-through of NCO's first home that is being retrofitted on May 1<sup>st</sup>.

Released an updated version of the CWMP Retrofit List and Minimum Quality Standards document on April 19<sup>th</sup>.

#### **EHP Update**

- FEMA's comments on the Biological Assessment have been transmitted and are being addressed now.
- FEMA is preparing a Biological No Effect Memo for the No Issue properties in the expanded areas, which will support our EHP clearance of the No Issue parcels under the project.

#### Site-Work Updates – Dulzura No-Issue Properties

- Project CWMPA-000471 Received One Contractor Quote and One Vegetation Management Quote.
- Final Revised Contractor Quote \$71,338.50 Includes Home Hardening and Hardscaping.
  - SDCFPD is working on a "Fair and Reasonable" report for review prior to the contract being issued.
- Vegetation Management work is complete and costs from the CCC's came in approximately half of the original quote.

# CWMP Update: San Diego County Fire Protection District in San Diego County Continued

### Site-Work Updates – Campo No-Issue Properties

- SDCFPD completed walk-thru with homeowner on 5/17/24, will be going out for bid solicitation
- Another assessment completed on a no-issue, stick built, 2-story home, next step will be developing a SOW
- Program Manager has contacted the HOA in Campo to set up a meeting to discuss the Wildfire Home Hardening grant program.

### Contractors

- SDCFPD re-opened the RFQ for Qualified Contractors. RFQ is now closed, and one additional C-47 (Manufactured Home) Contractor has expressed interest.
- SDCFPD is working on updating insurance requirements in Master Agreement to encourage more participation.

New Business

### State Legislative and Budgetary Inquires

**SB 946:** Wildfires: community hardening. This bill would state the intent of the Legislature to enact subsequent legislation related to community hardening to address risks resulting from wildfires. This bill would, for taxable years beginning on or after January 1, 2024, and before January 1, 2029, provide an exclusion from gross income for amounts received as a California qualified wildfire loss mitigation payment, as defined.

**AB 2469:** Existing law makes the operation of the program contingent upon an appropriation by the Legislature and repeals the program's provisions on July 1, 2025. This bill would extend the program's repeal date to July 1, 2030.
