Multiple Home Owner Cost Share Recommendations

- Owner occupied
- Assess owner income
- When there are multiple owners and not all live in the residence, assess the income based only on the owner(s) who occupy the property.
- Includes individual trusts when owner-occupied.
 - Assessing income based on HUD AGI methodology which includes household members.
- Owner non-occupied property (rental home)
- Assess owner income
- Includes individual trusts and multi-party trust
 - Assess income by taking the sum of all owners AGI considering the "household" members of the owners. This will be consistent with the owner-occupied method above; however, the household members of the owners are atypical as they don't reside in the project structure.
 - All owners plus "household" members would be utilized and applied to the HUD table to determine the income category.
- Homes owned by an LLC or Corporations
- Cost Share 25%

Outreach to Potential New Demonstration Communities

Siskiyou

SECTION 1. PURPOSE

This Agreement is made pursuant to Chapter 5 of Division 7 of Title 1 of the Government Code of the State of California, Sections 6500-6599.2 (the "Joint Exercise of Powers Act" or "JEPA") and Chapter 7 of Division 1 of Title 2 of the Government Code, Sections 8654.2-8654.1 O (collectively the "Statutes"), as the same may be amended from time to time, to provide for the joint exercise of powers common to Cal OES and CAL FIRE and the powers separately conferred by law upon the CWMP. The CWMP is created for the sole purpose of encouraging cost-effective structure hardening and retrofitting that creates fire-resistant homes, businesses, and public buildings, and facilitating vegetation management, the creation and maintenance of defensible space, and other fuel modification activities that provide neighborhood or communitywide benefits against wildfire. The purpose of this Agreement is to exercise those powers jointly by funding and managing programming to accomplish that purpose; the purpose will be accomplished, and those common powers jointly exercised as stated in this Agreement. The CWMP will fulfill the purposes of this Agreement by exercising the powers described in Section 4 in accordance with the Statutes and all other applicable laws.
