

Programmatic Agreement & Programmatic Biological Opinion

- Example Programmatic Agreement among the Federal Emergency Management Agency, the California State Historic Preservation Officer, and the California Governor's Office of Emergency Services. Effective: November 7, 2019.
 - Home Hardening Allowable Activities
 - F. Wildfire Recovery and Mitigation, when proposed activities substantially conform to the original footprint and/or are performed in previously disturbed soils, including the area where the activity is staged.
 - 4. Wildfire-Resistant Structure Hardening
 - a. Installation of a removable spark arrester on chimney and/or stovepipe outlets.
- Programmatic Biological Opinion U.S. Fish and Wildlife Service, Ecological Services Effective: 2019.
 - Programmatic Biological Opinion for the Federal Emergency Management Agency's Disaster, Mitigation, and Preparedness Programs

State Legislation Update: SB 946

The Governor signed **SB 946** (McGuire), Income Tax exclusion for wildfire mitigation payments. It is now Chapter 987, Statutes of 2024.

An act to add and repeal Sections 17138.8 and 24308.10 of the Revenue and Taxation Code, relating to taxation, to take effect immediately, tax levy.

SB 946, McGuire. Personal Income Tax Law: Corporation Tax Law: exclusions: wildfire mitigation payments. The Personal Income Tax Law and the Corporation Tax Law, in conformity with federal income tax law, generally defines gross income as income from whatever source derived, except as specifically excluded, and provides various exclusions from gross income.

This bill would, for taxable years **beginning on or after January 1, 2024, and before January 1, 2029**, provide an exclusion from gross income for amounts received by a qualified taxpayer, as defined, as a California qualified wildfire loss mitigation payment, as defined.

Existing law requires a bill authorizing a new tax expenditure to contain, among other things, specific goals the tax expenditure will achieve, detailed performance indicators, and data collection requirements.

This bill would include additional information required for any bill authorizing a new tax expenditure. The bill would authorize the Franchise Tax Board to provide specified data requested by the joint powers authority, as defined, and would make taxpayer information received by the joint powers authority subject to limitations on the collection and use of that information. By expanding the scope of a crime, this bill would impose a state-mandated local program.

This bill is in effect immediately as a tax levy.



State Legislation Update: Prop 4

- November 5, 2024
- Grants, in coordination with the Public Utilities Commission, to local agencies, state agencies, special districts, joint powers authorities, tribes, and nonprofit organizations for zero-emission backup power, energy storage, and microgrids for critical community infrastructure in order to provide continuity of electrical service, reduced wildfire ignitions, and to safeguard communities from disruption due to de-energization events, wildfire, or air pollution caused by wildfire, extreme heat, or other disaster.
- Grants under the Home Hardening Program to retrofit, harden, or create defensible space for homes at high risk of wildfire in order to protect California communities.

- General Scope of Work (based on approval to proceed):
 - Provide (1) remote site study
 - Prepare schematic guide to inform proposed work
- Execution of work
 - Confirm and Layout areas of work
 - Removal of plant materials and green waste
 - Remove waste materials from site (dumps and hauling)
 - Relocate/modify existing irrigation outside area of work
 - Prepare areas for permeable weed barrier and gravel
 - Placement of permeable weed barrier
 - Placement of gravel
 - Deliveries and equipment
- Excludes
 - New irrigation systems
 - Demolition of hardscape/walls
 - Drainage
 - Repairs to structure exterior (existing conditions i.e stucco, dry rot, waterproofing, etc.)
- 4 to 6 days per job Average
- 16 to 20 jobs for this period (based on average site 650 sf of work area)
- Estimated budget range per project \$20 to \$22/square foot per project



Costs to Homeowner

- The program is designed to eliminate barriers for disadvantaged communities to undertake mitigation activities and to incentivize wildfire home hardening and defensible space in the most socially vulnerable and highest fire risk communities.
- The program incorporates a "community hardening" strategy to fortify neighborhoods, as opposed to scattered sites of homeowners who have the means to harden their homes.
- To incentivize maximum neighborhood participation, the program covers the full cost of retrofit and defensible space implementation activities, upwards of \$40,000 (2020), for homeowners who make under 120 percent of the area median income. However, the CWMP is designed to work with all community members and has established income guidelines for participation.



Costs to Homeowner: 2020

To achieve mitigation benefits, we must encourage participation of as many homeowners in the demonstration areas as possible

- A sliding scale will allow all homeowners in target neighborhoods to participate to achieve maximum resiliency benefits without allocating substantial state funds to non-LMI participants.
- Participation limits promote lower income neighborhoods are prioritized.


