- A. Exchange of Extinguishers
 - 1) Section 557.5(g) "E" Definitions.

- i. (g) Exchange. The placement of a portable fire extinguisher meeting all applicable requirements in place of a portable fire extinguisher that requires service.

2) Section 575.10 Out of Service

- i. Fire extinguishers removed from service shall be immediately replaced with for maintenance or recharge shall be replaced and by a fire extinguisher suitable for the type of hazard being protected and shall be of at least equal rating as well as size. When the removal or replacement of fire extinguisher from installed location is necessary the owner or owner's agent shall be notified and documented

3) Section 591.5 Replacement Extinguisher

- i. Portable fire extinguishers shall not be removed from the premises for hydrostatic testing or any other purpose, without first replacing the extinguisher with a unit rated for the hazard being protected in accordance with section 575.10. When removed or replaced from installed location the owner or owner's agent shall be notified and documented. The customer's original unit shall be returned within 60 calendar days.

4) 557.15(a) "O" Definitions.

- i. Owner's agent. Is the employee, or tenant, authorized to give consent for work to be performed.
