#### **1. CALL TO ORDER**

##### **A. Welcome and Logistics Briefing.**

The meeting was called to order by Chairperson Brice Bennett at 9:05 A.M. PDT on October 29th, 2025. Attendees were informed of meeting logistics and etiquette.

##### **B. Committee Member Introductions and Roll Call.**

The Roll call was conducted by Wanda Albritten, and it was determined that there was a quorum, only (6 of 10) members were present.

**C. Introductions of Non-Committee Members.**

All attendees introduced themselves

**D. Approval of Past Meeting Minutes.**

October 29th, 2025, was approved at 9:15 a.m.

Chairperson Brice Bennett asked for approval of the minutes for the April 23<sup>rd</sup>, 2025, meeting. It was moved by Member Bobby Brown to approve of the minutes as presented; motion seconded by Member Kathy Newman motion was carried out with a unanimous vote in favor of approval of the April meeting minutes as presented.

**E. Announcements.**

Chairperson Brice Bennett stated he would pass the announcements over to Chief Jeffrey Schwartz. Chief Schwartz announced that Deputy Patricia Setter has retired. Chief Schwartz will be acting as coordinator until Deputy Jennifer Reiss starts on November 12, 2025. She will be the new Flame-Retardant Program Coordinator.

Chief Schwartz announced that Chief Brice Bennett has been promoted to the Division Chief for Fire Engineer & Investigation. Larry Godbout is the new Staff Services Manager I (SSMI) for Fire Engineer & Investigation Division. He will be overseeing the administrated staff along with Cortney Walker. Thomas Setnan has promoted to Associate Governmental Program Analyst (AGPA) working with Regulations.

**2. OLD BUSINESS**

**A. Non- Approved Online Tents Sales Update.**

Chairperson Brice Bennett stated that he has been investigating with other agencies, in particular, Department of Water Resources about showerheads online, and was unable to purchase high-flow showerheads online in California. Chief Bennett stated that going up against Amazon to try and tell them not to sell something is quite an undertaking.

**B. Chapter 8 Regulations Update.**

Chairperson Brice Bennett mentioned along with Chief Henning that (OSFM) will be adding a second attorney for the purpose of ensuring Regulation packages are progressing in a timely manner. This will safeguard that our Regulatory packages will go through Office of Administrated Law successfully.

**3. NEW BUSINESS**

**A. Individual Chemical Applicators vs Company Applicators.**

Member Kathy Newman stated that it's been requested by the general applicators, and limited applicators to mirror the same criteria as the Portable Fire Extinguisher Program's Certificate of Registration process. Member Kathy Newman wants to implement a subcommittee discussion workgroup. It was moved by members of a workgroup that Chief Schwartz will facilitate.

**4. OPEN FORUM**

Chairperson Brice Bennett opened the floor for an open forum. There were no comments in open forum.

## **5. PUBLIC COMMENT**

Chairperson Brice Bennett opened the floor for public comment.

Pat Dyas mentioned that he has over 45 years' experience as a show producer in the firework industry. He cited Health and Safety Code 13119 and 13115. He stated his concerns with Sacramento City Fire Department wanting all costumes to have Flame Retardant applied to them with a cost of \$30,000.00 dollars.

Chief Schwartz address Pat Dyas concerns with the Health and Safety Code and the City, County Ordinances.

Pat Dyas said that Sacramento Fire Department was requiring that Flame Retardant Program be placed on all costumes.

Member Bobby Brown asks the question of the age of the costumes used.

Eric Elias stated that NFPA 3 "Flaming Wardrobe Piano California" does not approve of these items such as drapery, hanging curtains items which primarily applies to stationary decorative items. Office of the State Fire Marshal (OSFM) agreed to provide Pat Dyas with information on filing a code interpretation request and it may not be completed before Disney's return in February.

Chief Brice Bennett said he would reach out to Pat Dayas to file for a code of interpretation.

Member Kathy Newman mentioned that she would like the results to be shared with the Committee after they have been answered.
