Discussion Items:

The following items on the agenda will be presented to the Pipeline Safety Advisory Committee (PSAC) immediately after the start of the public meeting. All discussion items indicated and the order of business are approximate and subject to change.

Agenda Item #

- 1. Public Meeting To Hear An Informational Update On The Proposed Regulations Requiring Best Available Technology On Pipelines Near Environmentally And Ecologically Sensitive Areas In Assembly Bill AB 864 (Williams 2015)**

The PSAC will hear an update on the proposed regulations, which require any new or replacement pipeline near environmentally and ecologically sensitive areas in the coastal zone to use best available technologies to reduce the amount of oil released in an oil spill to protect state waters and wildlife (California Government Code § 51013.1). The proposed regulation will also require pipeline operators to submit plans to retrofit existing pipeline with best available technology. The proposed regulation, among other

requirements, will define automatic shutoff systems, provide a process for evaluating an operator's risk analysis, and include a determination of how near a pipeline must be to an ecologically and environmentally sensitive area to be subject to the requirements of the regulation.

2. Public Meeting To Hear Best Procedures For Notifying Fire Local Fire Agencies When Conducting Inspections In Local Agency Jurisdiction

The PSAC will discuss alternatives and provide suggestions to the Office of the State Fire Marshal (OSFM) on how to notify local fire agencies of inspections in local jurisdictions.

3. Public Meeting To Hear Plan For Operator Information Session On Form PSD-101

The PSAC will hear a report on the OSFM's plan to educate operators on completing the required annual inspection report Form PSD-101. The Form PSD-101 will require pipeline operators to submit certain information on an annual basis to the OSFM. The information contained in the PSD-101 is part of regulations that are currently in final review with the Office of Administrative Law (California Government Code §51015.1).

OPPORTUNITY FOR MEMBERS OF THE PSAC TO COMMENT ON MATTERS OF INTEREST

PSAC members may identify matters they would like to discuss at future meetings and comment on topics of interest; no formal action on these topics will be taken without further notice.
