#### **Decisions Made**

- Continued prioritization of risk-based inspections

- Focus on resource allocation toward high-impact projects
- Agreement to review past inspection cycles (Ultramar and Valero sites) to ensure compliance within the 3-year cycle.
- The committee supported prioritizing inspections based on risk analysis.

### **Action Items**

- Staff to finalize inspection schedules for the upcoming cycle
- Legal team to provide follow-up on regulatory clarifications
- Division leads to prepare reports on major construction projects
- Public affairs to improve communication channels with stakeholders
- Staff to confirm reassignment of certain inspection responsibilities.
- Supervisors to provide updates on outstanding enforcement cases and major projects.
- Committee to reconvene in the next scheduled session with updated reports.

# **Opening Remarks**

The meeting began with a welcome message and the acknowledgment of a short delay to allow participants to join. The purpose of the annual meeting was confirmed, focusing on pipeline safety oversight and program updates.

#### Introduction

Participants introduced themselves, representing various divisions including administration, safety supervision, legal counsel, and the pipeline safety division. Collectively, the group emphasized its shared role in ensuring pipeline safety, compliance, and regulatory enforcement.

### **Program Updates**

The committee reviewed ongoing and planned activities, including risk-based inspections, compliance monitoring, and coordination across divisions. The importance of focusing resources on high-risk inspections and ensuring timely reporting was emphasized. Members also highlighted resource challenges and the need to allocate staff efficiently. Staff provided updates on program administration, inspection assignments, and regulatory frameworks. Specific mentions included: Standard main inspections (due every three years), Annual operator inspections and risk-based prioritization. Staffing updates and new role assignments within the Fire Marshal's Office.

#### **Legal & Regulatory Updates**

Legal counsel provided updates on oversight responsibilities and upcoming regulatory requirements. The discussion noted the importance of staying aligned with both federal and state standards while addressing challenges arising from resource limitations.

#### **Stakeholder Engagement**

The committee discussed the need for stronger engagement with stakeholders and the public. Ideas included improving communication channels, enhancing transparency, and providing clearer information to industry representatives.

## **Discussion**

- Quorum was confirmed for the committee to proceed.
- Participants discussed current challenges in scheduling inspections and aligning them with federal PHMSA expectations.
- Emphasis was placed on consistency between 'standard annual' and 'standard main' inspections.

# **Open Floor**

- Members raised questions on timelines, oversight authority, and delegation of responsibilities.
- Staff provided clarifications on program leads and available resources.

## **Closing Remarks**

The meeting concluded with consensus on finalizing inspection schedules, preparing detailed reports on construction and enforcement activities, and strengthening inter-division collaboration. The importance of transparency and proactive communication with stakeholders was reaffirmed.
