NWCG Course Updates and Retirements

Recommended Actions:

Approve FSTEP Course Updates and Retirements

Background Information:

State Fire Training (SFT) manages the curriculum and provides course completion diplomas for 162 courses. SFT identified the discrepancies between the SFT website, Procedures Manual, and the Course Information and Required Materials Manual (CIRM). Several courses are now retired or have not been delivered since 2015.

Analysis/Summary of Issue:

The following courses were retired by NWCG or have been in the SFT system but have not been delivered in 5 years. If at a future date, there is a demand SFT can add the courses back into the SFT course catalog for delivery (does not apply to S-336). SFT will retire these courses upon State Board of Fire Services approval.

IMPLEMENTATION PLAN NWCG Course Updates and Retirements

OVERVIEW

State Fire Training (SFT) manages curriculum and provides course completion diplomas for 162 courses. SFT reviewed the National Wildfire Coordinating Group (NWCG) courses listed in the Course Information and Required Materials Manual (CIRM). Several courses have been updated to new editions, and a few were retired by NWCG. This Implementation Plan provides updates and retirements for select NWCG Courses.

CURRICULUM IMPLEMENTATION

SFT recognizes that many SFT Instructors, Accredited Academies, Agencies, and stakeholders are invested in the current curriculum. The current curriculum and instructor requirements will apply to courses hosted during the transition period.

Accredited Regional Training Programs (ARTP), Accredited Local Academies (ALA), community colleges, and all other local delivery venues need to review the curriculum and seek approval from their curriculum committee/program sponsor, as appropriate. ARTPs should review the new curriculum and discuss potential impacts with their advisory committees.
