### SUBJECT/AGENDA ACTION ITEM:

Fire Fighter Rescue and Rapid Intervention Crew (RIC) Operations (2023) Curriculum Update

### **Recommended Actions:**

Information/discussion

### **Background Information:**

Update to State Fire Training's RIC Operations (2010) curriculum and intention to correlate with International Association of Fire Fighters' Fire Ground Survival program (currently under development). This curriculum allows students to recognize and engage in skills necessary to minimize errors on the fire ground and reduce fire fighter injuries and fatalities using timely and relevant information and techniques.

### Analysis/Summary of Issue Standard:

### **Course Plan**

- Expanded course time from 24 to 32 hours to accommodate increased content focusing on fire fighter rescue separate from, and potentially prior to, RIC operations. This decision is based on current statistics (<u>www.projectmayday.com</u>) indicating that:
  - Fire fighter self-rescues (35.5% of the time)
  - Fire fighters rescue fellow crew member (26.1% of the time)
  - Adjacent crew(s) performs fire fighter rescue (25.3% of the time)
  - Rapid Intervention Crew(s) performs fire fighter rescue (6.6% of the time)

- Prerequisites
  - Made *both* IAFF's online Fire Ground Survival Awareness course (completed within 90 days of SFT course start date) and SFT's Fire Fighter Survival required instead of either/or. SFT updated Fire Fighter Survival and Fire Rescue and RIC Operations in tandem to work together in building a fire fighter's skill set.
- Maximum class size changed from 40 to 50
- SFT's updated course does not maintain reciprocity with IAFF's Fire Ground Survival Operations course at this time. SFT will review IAFF's updated curriculum when it is released to reevaluate reciprocity.

### Instructor and Student Guide

• SFT did not update and will no longer support the RIC Operations Instructor and Student Guide (December 2011).

### Instructor Task Book (Instructor Requirements)

### Existing Registered Instructors

Due to substantial updates to the existing RIC Operations (2011) curriculum, current RIC Operations Registered Instructors must complete the following requirements to receive authorization to teach Fire Fighter Rescue and RIC Operations (2023).

- Fire Ground Survival Awareness (IAFF online / Must be completed within 3 years prior to the Fire Fighter Rescue and RIC Operations course start date.)
- Fire Fighter Rescue and RIC Operations Instructor Update Course (IUC) virtual session to address the new FFR-RIC OPS content
- Instructor Update verification web form available on the SFT User Portal

Instructors who do not complete these requirements prior to June 30, 2024, will be required to apply to SFT under the new instructor requirements.

### Instructor Candidates with an Open Task Book

Instructor candidates actively working on a RIC Operations instructor task book must complete and submit their task book to SFT postmarked by June 30, 2024. Instructor candidates who do not complete their task book prior to June 30, 2024, will be required to apply to SFT under the new instructor requirements.

### New Instructor Registration

New instructors shall:

- Be an OSFM Registered Instructor
- Complete one of the following course work options:
  - Fire Fighter Rescue and RIC Operations (2023) course (SFT)
  - RIC Operations (2011) and Fire Ground Survival Awareness (IAFF online – completed within three years prior to applying for instructor registration)
- Complete the Fire Fighter Rescue and RIC Operations (2023) Instructor Task Book

### Staff Report Fire Fighter Rescue and RIC Operations (2023)

- Have two years' full-time or four-years part-time/volunteer suppression and rescue experience within a recognized fire agency in California
- Provide a letter signed by their Fire Chief or authorized designee that verifies qualification to deliver Fire Fighter Rescue and RIC Operations (2023) training
- Submit an SFT Instructor Registration Application and pay the registration fee

### Cadre Members

To become a Registered Instructor after serving on the curriculum development cadre, a candidate must be an SFT Registered Instructor. Cadre members are not required to complete the following:

- Fire Ground Survival Awareness (IAFF online)
- Fire Fighter Rescue and RIC Operations Instructor Update Course (IUC) virtual session
- Instructor Update verification web form available on the SFT User Portal

### **Student Training Record**

# FIRE FIGHTER RESCUE AND RAPID INTERVENTION CREW (RIC) OPERATIONS (2023) Implementation Plan

### **OVERVIEW**

This document provides information for all State Fire Training (SFT) stakeholders on the revised Fire Fighter Rescue and RIC Operations (2023) curriculum and instructor requirements. Stakeholders are encouraged to study this information carefully and seek clarification from SFT if questions arise.

The Fire Fighter Rescue and RIC Operations curriculum and instructor requirements will be phased in for the Fire Service Training and Education Program (FSTEP). SFT developed a new course plan based on the following current National Fire Protection Association (NFPA) Standards:

- NFPA 1407: Standard for Training Fire Service Rapid Intervention Crews;
- NFPA 1500: Standard on Fire Department Occupational Safety, Health, and Wellness Program; and
- NFPA 1710: Standard for the Organization and Deployment of Fire Suppression Operations, Emergency Medical Operations, and Special Operations to the Public by Career Fire Departments.

SFT also considered FIRESCOPE and OSHA reference documents in the development of this curriculum. The course plan and associated course materials are now available on the SFT website.

### **IMPLEMENTATION**

SFT recognizes that many candidates are vested in the current RIC Operations instructor development track and therefore, the existing RIC Operations (2011) curriculum will be available for those candidates during the transition period. Candidates entering the SFT system should enroll in the new Fire Fighter Rescue and RIC Operations course and comply with the new Fire Fighting and Rescue instructor requirements.

**Retirement of Fire Fighter RIC Operations (2011) Curriculum......June 30, 2024** Effective June 30, 2024, SFT will retire the FSTEP RIC Operations (2011) curricula from the SFT course catalog and it will no longer be available.

### **INSTRUCTOR REQUIREMENTS**

### Instructor Candidates with an Open Task Book

Instructor candidates who do not complete their task book prior to June 30, 2024, will be required to apply to SFT under the new instructor requirements.

### New Instructor Registration

To become a Registered Instructor for this curriculum, a candidate must:

- Be an OSFM Registered Instructor
- Complete one of the following course work options:
  - Fire Fighter Rescue and RIC Operations (2023)
  - RIC Operations (2011) **and** Fire Ground Survival Awareness (IAFF online completed within three years prior to applying for instructor registration)
- Complete the Fire Fighter Rescue and RIC Operations (2023) Instructor Task Book
- Have two years' full-time or four-years part-time/volunteer suppression and rescue experience within a recognized fire agency in California
- Provide a letter signed by their Fire Chief or authorized designee that verifies qualification to deliver Fire Fighter Rescue and RIC Operations (2023) training
- Submit an SFT Instructor Registration Application and pay the registration fee

### **POTENTIAL AGENCY IMPACTS**

Fire agencies desiring to use the Fire Fighter Rescue and RIC Operations curriculum as a requirement for their recruitment/promotion activities need to review the curriculum requirements to ensure all agency training needs are being met. After review, fire agencies should update their job specifications and recruitment documentation to reflect the new course requirements.

Accredited Regional Training Programs (ARTP), Accredited Local Academies (ALA), community colleges, and all other local delivery venues should review the curriculum and seek approval from their curriculum committee/program sponsor, as appropriate. ARTPs should review the new Fire Fighter Rescue and RIC Operations curriculum and discuss potential impacts with their advisory committees.

### Facilities

The following facilities are required to deliver this course:

- Standard learning environment or facility, which may include:
  - Writing board or paper easel chart

  - Internet access with appropriate broadband capabilities
- A training site with the facilities, structures, work areas, materials, props, tools, and equipment of adequate size, type, and quantity to fully and safely support the cognitive and psychomotor training required to deliver the curriculum

### Equipment

Student safety is of paramount importance when conducting the type of high-risk training associated with this Machinery Rescue Technician (2021) course.

- The equipment listed below is the minimum for the delivery of this course.
- The student is responsible for providing all PPE and ensuring that all PPE meets AHJ and site requirements.

• For all tools and equipment, ensure that you have the power source, operating supplies (blades, fuel, etc.), cleaning supplies, and appropriate PPE.

### **Training Props**

The following training props are required to deliver this course:

- Simulated structure
  - Minimum two stories with windows on each floor with ladder positioning access
  - Three or more rooms no less than 10'x10'
    - Must have movable furnishings that can be moved from room to room
    - Must be able to be darkened
  - Anchoring points must be available on each floor for securing belay systems
  - Two or more entrances/exits to structure
- Simulated roof prop
  - Elevated preferred with fall protection anchoring available
- Simulated attic prop
- Below grade prop

- 8-10 feet between floors, access opening minimum 2'x2', fall protection anchoring
- Breaching and profiling prop
  - Simulated stud wall 16" on center, with drywall
- Confined area prop
  - Small or restricted space to perform rescue/disentanglement

Ensure that ropes and equipment used for safety belay system within elevated skills are consistent with NFPA 2500 as a minimum. Ensure upper floor egress belay systems are set-up and tended by trained personnel.

The course provider or agency assumes all responsibility, liability, and maintenance for the engineering design, strength, stability, and adequacy of all props, including anchor points and tie offs. The provider or agency further assumes all responsibility, liability, and maintenance for all tools, equipment, and supplies used at the site for the delivery of a Fire Fighter Rescue and RIC Operations class. This includes, but is not limited to, ladders, ropes, hardware, and software.

### Personnel

The following personnel are required to deliver this course:

- Any instructor counted toward student ratios, including application components, must be an SFT Registered Fire Fighter Survival and RIC Operations Instructor.
- SFT strongly recommends the use of Skills Coaches as supplemental support to assist with application and skills proficiency practice.
- The use of Skills Coaches as supplemental support does not negate the 1:10 instructor/student ratio requirement.

### **Time Table Key**

- 1. The Time Table documents the amount of time required to deliver the content included in the course plan.
- Time is documented using the quarter system: 15 min. = .25 / 30 min. = .50 / 45 min. = .75 / 60 min. = 1.0.

      - Traumatic injury
      - Significant medical emergency
      - Unconscious
      - Unable to assist in their own rescue
    - Initial RIC has consumed air supply and another team is needed to continue search or assist in fire fighter rescue/removal
    - Multiple fire fighters in need of rescue (i.e., ceiling or floor collapse traps company)

• Heavy equipment operations

  - RIC tools and equipment can mean difference between life and death
  - Don't let other resources remove items from cache
  - Needs to be fully equipped and ready to deploy at all times

  - Place in strategic and advantageous positions
  - Structure corners are good staging locations
  - Need to be able to begin RIC operations from any point around or inside structure
  - May need to stage RIC tools in multiple locations
- 7. Identify how incident and conditions impact tool selection
  - Initial/immediate intervention
    - Must bring RIC pack
    - o Don't overload with tools and equipment
    - Need to search and move in rapid fashion
    - Extended intervention
      - o Bring tools appropriate to fire fighter rescue situation
      - Relocate tools closer to site (if possible)
- 8. Assemble a mobile tool cache

#### **Enabling Learning Objectives**

  - Number of RICs assigned to an incident
  - Construction
    - In high rise, position on floor below fire-fighting operations
    - o Big box structure, position at point of entry on opposing Divisions
    - Single family dwelling, position near highest risk
  - Fire conditions
  - Incident complexity
- 2. Describe the benefits and limitations of positioning RIC at a designated location
  - Benefits
    - Resources located near entry point of interior crews
    - Remain near area of highest risk
    - o Allows fast access to area of working crews while reserving air for rescuers
    - o Structure corners provide ability to monitor two sides of structure
    - Ease of possible face-to-face communication with command (when command post located near primary entry point)
    - Can aid in accountability
  - Limitations
    - o Limits view of structure and changing conditions
    - Reduces familiarity with access and egress points
    - Tendency to overload on excessive/unnecessary tools and equipment
- 3. Describe benefits and limitations of mobile RIC positioning
  - Benefits
    - Allows for continuous assessment of structure and changing conditions on all sides
    - Focuses tool selection to keep resources light/fast
    - Increases familiarity with access and egress points
    - Potentially positions resources near secondary/closer access points
  - Limitations
    - Reduces ability for face-to-face communications with IC or Operations (when command post located near primary entry point)
    - Can negatively impact ability to track resources entering structure (maintaining accountability)
- 4. Position a RIC on the fire ground

  - Identifies utility locations and shut offs
  - Reduces reflex time to access and remove downed fire fighter

  - Doors

    - Construction
    - Locking mechanism
    - Hinges (exposed vs. unexposed)
    - o Security bars
  - Windows
    - o Glass type
    - o Height
    - o Width
- 3. Describe how to soften a structure
  - Board ups
  - Security bars and gates
  - Obstacles
- 4. Identify additional considerations
  - Structure dictates complexity of softening operations
  - Exterior crews must always coordinate with interior crews to assure they do not change flow path and fire behavior, endangering personnel engaged in fire attack
  - Additional softening or breaching may be necessary during active fire fighter rescue
     Performed by additional crews or secondary RIC
- 5. Soften a structure

### **Unit 7: RIC Operations**

#### **Topic 7-1: Searching for a Downed Fire Fighter**

#### **Terminal Learning Objective**

At the end of this topic a student, given a downed fire fighter scenario, tools and equipment, AHJ policies and procedures, and best practices, will be able to search for a downed fire fighter as a member of a RIC so that personal orientation is maintained, air consumption is managed, and downed fire fighter is located in accordance with AHJ policies and procedures and best practices.

#### **Enabling Learning Objectives**

- 1. Identify information relayed during a Mayday call
  - Who, What, Where, Air
  - LUNAR location, unit, name, assignment, resources needed
  - NUCAN name, unit, conditions, actions, needs
  - HELP handle (name), equipment (company assignment), location, problem
- 2. Describe importance of air management during search operations
  - Rule of Air Management determined by AHJ
  - May not have enough air to complete search assignment
- 3. Identify basic search method options
  - Targeted search
  - Oriented search
    - o TIC
    - o Rope
    - o Hose
  - Split search
  - Vent, enter, isolate, search (VEIS)
- 4. Describe how to search as part of a RIC
  - Identify strategic entry point
  - Travel to last known or transmitted location
  - Maintain personal orientation during travel/search
    - o Building layout
    - Hoseline
    - o TIC
    - o Rope
  - Look for flashing lights
  - Listen for PASS device or audible cues
  - Monitor radio communication for updates
- 5. Describe benefits and limitations of searching with a TIC
- 6. Identify types of ropes used in search operations
  - Search line
    - 150-200 feet of rope in a rope bag
    - May include company identifier

- Search line system
  - 200, 210, 220 feet of Kevlar rope (3/8" or 7/16") in a rope bag
    - 200 feet inside building (10 or 20 feet outside for anchor)
  - Pre-set knots at 20 feet indicate depth
  - Pre-set rings at 20 feet indicate direction
  - Load into bag so ring comes out first followed by knot(s)
    - During entry, ring comes before knot(s) on the line
    - During exit, ring comes after knot(s) on the line and lead to exit/egress
  - o Tethered line
    - 20 feet with a knot at 10 feet, a non-locking carabiner at one, and a slip knot at the other end
    - Clips to search line system rings so RIC can search outward from search line
    - Can also use a drop bag/bailout rope
- 7. Describe how to conduct a point-to-point search using rope
  - Anchor rope or search line system outside structure
    - $\circ$  Anchor to a fixed object
    - Should be suspended three feet off ground
  - Deploy into structure following straightest path for egress
  - Tie off rope line at any potential exit/egress point between entry point and downed fire fighter
    - Keep rope between one to three feet off ground
  - When fire fighter is found, tie off rope line near location
  - Follow rope from downed fire fighter to nearest point of exit/egress
- 8. Describe advantages and disadvantages of using rope for search
  - Advantages
    - Provides an anchor for rapid search
    - o Provides a reference for depth into structure
    - Provides directional reference for RIC inside structure
    - Provides multiple anchor points for RIC to work from
    - Provides reliable path of traffic for access and egress to/from downed fire fighter
  - Disadvantages
    - May cause entanglement hazard
    - Improper use or damage may cause evacuation delays
    - May be challenging to tie off inside structure
    - Cumbersome/awkward to carry
- 9. Describe how to follow an attack hoseline to a downed fire fighter
  - Locate hoseline
  - Search hoseline until locating coupling
  - Find male coupling (lugs are larger and run entire length)
    - o "Smooth, Bump, Bump, to the Pump"

- "Long Lugs Lead Out"
- Follow hoseline to exit structure
- 10. Describe advantages and disadvantages of searching using an attack hose line
  - Advantages of an established attack hoseline
    - May lead directly to downed fire fighter
    - May lead back to known entry location
    - May provide protection when reaching end of hoseline
    - May eliminate need for additional hoseline or search line as an anchor for access or egress
    - o May extend search area using hoseline as additional anchor point
    - Couplings can serve as distance and directional markers
  - Disadvantages of an established attack hoseline
    - Multiple hoselines can cause confusion
      - Original path of travel may be compromised
- 11. Describe how to use 1" charged hoseline for search
  - Determined amount of hose needed
    - Multiple pre-determined lengths coupled together
  - Deploy hose to point of entry
  - Clip rescuer to hoseline
  - Travel to downed fire fighter
    - Designated fire fighter at entry point communicates distance travelled measured by coupling
  - Follow hoseline out
- 12. Describe advantages and disadvantages of searching using a 1" charged hose line
  - Advantages
    - Fire fighters use regularly and are comfortable maneuvering it through a structure
    - May lead back to known entry location
    - May provide protection during deployment
      - Not intended for fire attack
  - Disadvantages
    - May need to split up at corners/friction/pinch points
    - May be challenging to advance while carrying RIC pack and other tools
    - May lead to consuming more air than other options
    - Multiple hoselines may cause confusion
- 13. Identify factors that influence search decision making and process
  - Number of rescue personnel on site
    - Working alone vs. part of a crew
    - Larger or multiple search teams have ability to search larger or multiple rooms/areas simultaneously (center hallway, rope based, extension off an orienting wall or building feature, etc.)
  - Complexity of fire fighter rescue
  - Number of downed fire fighters

- Structure and fire conditions
- Access and egress points
  - RIC can enter structure at any access point, not just from downed fire fighter's point of entry
  - Initial path of travel may be blocked by collapse or fire conditions
  - May enter structure at alternate elevation using ground ladders or aerial device
  - o Additional softening or breaching may be needed
- 14. Search using hose line for orientation
- 15. Search using rope for orientation
- 16. Search using building features for orientation
- 17. Search using a TIC for orientation

#### **Enabling Learning Objectives**

- 1. Describe a RIC pack
  - Large volume dedicated air source for downed fire fighter that does not impact rescuer's personal air supply
- 2. Describe RIC air delivery options (based on PAC-CAN findings)
  - Trans fill via RIC universal air connection (UAC)
    - No respiratory exposure to environment
    - Downed fire fighter not tethered to RIC pack
    - RIC pack available for multiple downed fire fighters or rescuer emergency
  - Using emergency breathing safety system (EBSS)
    - Downed fire fighter tethered to RIC pack, must move with SCBA and RIC pack
  - MMR swap
    - Allows removal if downed fire fighter's SCBA is damaged, but face piece is not
    - If downed fire fighter is only partially removed to exterior, they have no PASS device to guide next RIC
    - Respiratory exposure to environment
  - Full face piece swap
    - Only done if absolutely necessary (damage or missing/removed face piece)
    - Requires coordination of multiple RIC members in possible reduced visibility conditions
    - Respiratory exposure to environment
- 3. Deliver air to a downed fire fighter

### How to Read a Course Plan

#### **Course Details**

The Course Details segment identifies the logistical information required for planning, scheduling, and delivering a course.

#### **Required Resources**

The Required Resources segment identifies the resources, equipment, facilities, and personnel required to deliver the course.

#### Unit

Each Unit represents a collection of aligned topics. Unit 1 is the same for all SFT courses. An instructor is not required to repeat Unit 1 when teaching multiple courses within a single instructional period or academy.

#### Topics

Each Topic documents a single Terminal Learning Objective and the instructional activities that support it.

#### **Terminal Learning Objective**

A Terminal Learning Objective (TLO) states the instructor's expectations of student performance at the end of a specific lesson or unit. Each TLO includes a task (what the student must be able to do), a condition (the setting and supplies needed), and a standard (how well or to whose specifications the task must be performed). TLOs target the performance required when students are evaluated, not what they will do as part of the course.

#### **Enabling Learning Objectives**

The Enabling Learning Objectives (ELO) specify a detailed sequence of student activities that make up the instructional content of a lesson plan. ELOs cover the cognitive, affective, and psychomotor skills students must master to complete the TLO.

#### **Discussion Questions**

The Discussion Questions are designed to guide students into a topic or to enhance their understanding of a topic. Instructors may add to or adjust the questions to suit their students.

#### Application

The Application segment documents experiences that enable students to apply lecture content through cognitive and psychomotor activities, skills exercises, and formative testing. Application experiences included in the course plan are required. Instructors may add additional application experiences to suit their student population if time permits.

#### Instructor Notes

The Instructor Notes segment documents suggestions and resources to enhance an instructor's ability to teach a specific topic.

#### **CTS Guide Reference**

The CTS Guide Reference segment documents the standard(s) from the corresponding Certification Training Standard Guide upon which each topic within the course is based. This segment is eliminated if the course is not based on a standard.

#### **Skill Sheet**

The Skill Sheet segment documents the skill sheet that tests the content contained within the topic. This segment is eliminated if the course does not have skill sheets.

### Purpose

The State Fire Training instructor task book is a performance-based document. It lists the minimum requirements a candidate must meet to teach a specific State Fire Training course or course series.

### Assumptions

Except for Fire Fighter and Emergency Vehicle Technician (EVT) certifications, a candidate may begin the task book initiation process upon completion of all required education components (courses).

Each job performance requirement (JPR) shall be evaluated after the candidate initiates the task book.

State Fire Training task books do not count towards the NWCG task book limit. There is no limit to the number of State Fire Training task books a candidate may pursue at one time if the candidate meets the initiation requirements for each.

It is the candidate's responsibility to routinely check the State Fire Training website for updates to an initiated task book. All State Fire Training issued updates to an initiated task book are required for task book completion.

A candidate must complete a task book within three years of its initiation date. Otherwise, a candidate must initiate a new task book using the certification's current published version.

# **Roles and Responsibilities**

### Candidate

The candidate is the individual pursuing instructor registration.

#### Initiation

The candidate shall:

- 1. Complete the Initiation Requirements section.
  - Please print.
- 2. Complete a block on the Signature Verification page with a handwritten signature.

#### Completion

The candidate shall:

- 1. Complete all Job Performance Requirements.
  - Ensure that an evaluator initials, signs, and dates each task to verify completion.
- 2. Complete the Completion Requirements section.
- 3. Sign and date the Candidate verification section on the Review and Approval page with a handwritten signature.
- 4. Obtain their fire chief's handwritten (not stamped) signature on the Fire Chief verification section on the Review and Approval page.
- 5. Create and retain a physical or high-resolution digital copy of the completed task book.

### Submission

The candidate shall:

- 1. Submit a copy (physical or digital) of the completed task book and any supporting documentation to State Fire Training.
  - See Submission and Review below.

A candidate should not submit a task book until they have completed all requirements and obtained all signatures. State Fire Training will reject and return an incomplete task book.

### **Evaluator**

An evaluator is any individual who verifies that the candidate can satisfactorily execute a job performance requirement (JPR).

A qualified evaluator is a Registered Instructor of RIC Operations or Fire Fighter Rescue and Rapid Intervention Crew (RIC) Operations designated by the candidate's fire chief (or authorized designee). For instructor task books that do not require fire chief initiation, academy instructors serve as or designate evaluators.

An instructor task book may have more than one evaluator.

All evaluators shall:

- 1. Complete a block on the Signature Verification page with a handwritten signature.
- 2. Review and understand the candidate's instructor task book requirements and responsibilities.
- 3. Verify the candidate's successful completion of one or more job performance requirements through observation.
  - Do not evaluate any job performance requirement (JPR) until after the candidate initiates the task book.
  - Sign all appropriate lines in the instructor task book with a handwritten signature or approved digital signature (e.g., DocuSign or Adobe Sign; a scanned copy of a signature is not acceptable) to record demonstrated performance of tasks.

### **Fire Chief**

The fire chief is the individual who initiates (when applicable) and then reviews and confirms the completion of a candidate's instructor task book.

A fire chief may identify an authorized designee already on file with State Fire Training to fulfill any task book responsibilities assigned to the fire chief. (See *State Fire Training Procedures Manual*, 4.2.2: Authorized Signatories)

### Initiation

The fire chief shall:

- 1. Review and understand the candidate's instructor task book requirements and responsibilities.
- 2. Complete a block on the Signature Verification page with a handwritten signature.
- 3. Designate qualified evaluators.

### Completion

The fire chief shall:

- 1. Confirm that the candidate has obtained the appropriate signatures to verify successful completion of each job performance requirement.
  - Ensure that all job performance requirements were evaluated after the initiation date.

- 2. Confirm that the candidate meets the Completion Requirements.
- 3. Sign and date the Fire Chief verification statement under Review and Approval with a handwritten signature.
  - If signing as an authorized designee, verify that your signature is on file with State Fire Training.

### Submission and Review

A candidate should not submit a task book until they have completed all requirements and obtained all signatures. State Fire Training will reject and return an incomplete task book.

To submit a completed task book, please send the following items to the address below:

- 1. A copy of the completed task book (candidate may retain the original)
- 2. All supporting documentation
- 3. Payment

# **Job Performance Requirements**

### Job Performance Requirements

The candidate must complete each job performance requirement (JPR) in accordance with the standards of the authority having jurisdiction (AHJ) or the National Fire Protection Association (NFPA), whichever is more restrictive.

When California requirements exceed or require revision to the NFPA standard, the corresponding Office of the State Fire Marshal approved (OSFM) additions or revisions appear in italics.

All JPRs must be completed within a California fire agency or State Fire Training Accredited Regional Training Programs (ARTP).

Each JPR shall be evaluated after the candidate initiates the task book.

Each task must be performed twice.

- The two instances must occur during two different courses.
- The same evaluator cannot sign off on the same task twice.
- In the tables, E1 represents the candidate's first evaluation and E2 represents their second evaluation.

## Selecting RIC Tools

The complexity of a RIC emergency will dictate the required tools and equipment. Unfortunately, the true complexity of the RIC emergency is often unknown until the downed fire fighter is located. That's why it is essential to assemble a fully functional and adequate tool cache every time your company is assigned to a RIC.

#### **Five Considerations**

When assembling a tool cache, consider the five main RIC operations:

- Ingress/Egress
- Search
- Air delivery
- Gaining access to a downed fire fighter
- Packaging a downed fire fighter

Specific tools and equipment will vary by agency. An ongoing and thorough size up of the structure will also dictate any other tools or equipment that may be required.

The RIC tool cache belongs to the RIC. Do not allow other resources to remove any items from your cache. The tools and equipment used by the RIC can mean the difference between life and death for a downed fire fighter. The RIC tool cache should be fully equipped and ready to deploy at all times.

#### Ingress and Egress Tools

- Irons (flathead axe and Halligan)
  - Forcible entry
  - Creating an opening
- Chain saw
  - Removing doors
  - Enlarging openings
  - Creating an opening
- Circular saw
  - Removing bars
  - Removing metal doors
  - Removing locks
  - Enlarging openings on masonry/metal buildings
  - Creating openings on masonry/metal buildings
- Reciprocating saw
  - o Removing bars
  - Removing locks
  - Enlarging openings

- Creating an opening
- Cutting torch
  - o Removing bars
  - o Removing rebar
  - $\circ \quad \text{Removing locks} \quad$
- Through the lock tools
  - o Removing locks and hardware
- Bolt cutters
  - o Removing chains
  - Removing pad locks

#### Search Tools

- Handled tools
  - Allows further reach from anchor points
  - Allows for greater person-to-person reach
- Standard rope
  - Provides an anchor in a rapid search
- Search lines
  - Provides an anchor for a rapid search
  - Provides a reference of depth into the structure
  - o Provides directional reference for the RIC once inside the structure
  - o Provides multiple anchor points for the RIC once inside the structure
- Webbing
  - Allows further reach from anchor points
  - Allows for greater person-to-person reach
- Thermal imager
  - Allows for greater visibility within the structure during search
  - Allows the RIC to identify hazards, exits, and fire fighters within the structure
  - o Allows the RIC to identify temperatures within the structure

#### Air Delivery Tools

- Spare SCBA
  - Equipped with spare mask
  - Allows for regulator or mask changeover
- RIC air
  - Equipped with spare mask
  - Equipped with a universal air connector (UAC)
    - Identify whether your department and neighboring departments comply with NFPA 1981: Standard On Open-Circuit Self-Contained Breathing Apparatus For Emergency Services (2019 edition), stating that all new

SCBAs will have a standard universal air connection (UAC) regardless of the manufacturer.

- Equipped with an additional mask mounted regulator (MMR)
- Allows downed fire fighters to have their own air to breath
- Trans fill lines
  - Utilized for SCBAs with UAC
- Buddy breathing system
  - Present on many newer SCBAs
  - Downed fire fighter is now utilizing the same air as a RIC member
- Plastic tubing
  - Can be used as a mask-to-mask buddy breathing system if no other air delivery equipment is available

#### Access Tools

- Wire cutters
  - Retrieval of an entangled fire fighter
  - Spring loaded
- Pneumatic lifting tools
  - Heavy lifting in an entrapment situation
- Hydraulic lifting tools
  - Heavy lifting in an entrapment situation
- Pry bars
  - Heavy lifting in an entrapment situation
- Saw (chain, circular, or reciprocating)
  - Removal of debris from around a downed fire fighter

Much of the equipment used to remove heavy debris off a trapped fire fighter is heavy and cumbersome. Searching with these heavy items will slow progress and cause fatigue. The RIC should stage heavy equipment at a strategic point for rapid deployment when needed.

#### Packaging

- Tubular webbing
  - Lightweight and versatile
  - Can be used as a harness
  - Can be used as a drag handle
- Rescue loops
  - Lightweight and versatile
  - Rapidly deployed
    - Provides drag and lifting handles
- Drag devices
  - Typically lightweight and versatile

- Rapidly deployed
- Protects the downed fire fighter from any further entanglement by encapsulating them
- Rescue litter
  - Strong and sturdy
  - Large and cumbersome
  - Securing the downed fire fighter in the basket can be difficult in a limited visibility environment
  - Provides a means to move tools and equipment
- SKED
  - Slides well on most surfaces
  - Lightweight but bulky
  - Provides multiple drag and carrying handles
  - Can be difficult to deploy and secure a downed fire fighter in a low visibility environment
  - Protects the downed fire fighter from any further entanglement by encapsulating them
