NFA Course Reciprocity Update

Recommended Actions:

Background Information:

State Fire Training (SFT) recognizes courses offered by other agencies and institutions as reciprocal to similar courses offered through SFT. Individuals who have completed an approved reciprocal course may apply and pay a fee to receive an SFT course completion diploma without having to complete the SFT course.

Analysis/Summary of Issue:

Several National Fire Academy (NFA) courses listed in the Table 9.1.2: SFT Approved Courses, from the SFT Procedures Manual (May 2020), Chapter 9, have either changed course names/codes, become obsolete, or retired since the last publication of the SFT Procedures Manual.

SFT recommends implementing the actions listed in the revised table below. In some cases this would include removing the approved reciprocal course from the table when there is no alternative. Other approved courses in the list should be updated to reflect either a change in the course title has been made or another course within the NFA catolog would be a more appropriate surrogate for the SFT training.
