 - i. Wildfire Preparedness
 - 1. Defensible Space
 - a. We have completed our first Qualified Entity training requested from Tuolumne County. We are scheduling additional classes to begin in June.
 - b. Statewide SRA Total for Fiscal Year 2023-2024:
 - i. 198,659 inspections completed, 79% of the goal 250,000 goal
 - c. Burn Permits
 - i. 55,928 requested 50,877 issued
 - ii. 101,979 issued since the January 3, 2023 launch.
 - 2. Home Hardening
 - a. Attended Fire Safety Research Institute (FSRI) WUI Advisory Committee Meeting.
 - b. Supporting North Coast Opportunities CWMP Lake County pilot community, with the retrofitting of their first home.
 - 3. Utility Wildfire Mitigation Program
 - a. Utility companies have begun to submit their 2025 WMP updates.
 - i. Publishing updates are scheduled to be completed by 7/2/2024 for PG&E, SCE, and BVES.

- Publishing updates are scheduled to be completed by 10/8/2024 for PacifiCorp, Liberty, Trans Bay, Horizon West, and LS Power.
- b. PRC 4292/4293 and powerline equipment identification has begun for the Unit DSI programs.
- c. Utilities have begun their annual PSPS training exercises. These will last until mid-summer.
- i. Wildfire Planning and Statistics
 - 1. Fuel Reduction Projects
 - a. 651 projects, 130.2% of the goal
 - 2. Combined Fuel Reduction
 - a. 64,435.1 acres treated, 64.4% of the goal
 - i. Unit Projects 31,320 acres
 - 1. Northern Region: 20,033.5 acres
 - 2. Southern Region: 11,286.4 acres
 - b. Grant Projects: 27,992 acres
 - c. CFIP Projects: 5,123.1 acres
 - 3. Prescribed Fire (also counted in fuel reduction)
 - a. 21,679.2 acres treated, 43.4% of the goal
 - 4. Fire Prevention Efforts FY 19/20 through 22/23

- 6. Wildlands Fuels Reduction Reporting
 - a. Quarterly CalMAPPER (QA/QC) completed on schedule ahead of reports being re-locked.
 - b. Been working with vendor and internally on development of CalMAPPER ver. 4 desktop and mobile app. Major schema change to ease data entry, help track planned work, and collaborative work.
- 7. Fire Hazard Severity Zones
 - a. The State Responsibility Area (SRA) regulation was approved by the Office of Administrative Law on January 31, 2024 and became effective on April 1, 2024.
- 8. CalStats
 - Working with units to finish 2023 reports that remain outstanding in our CAL FIRE Incident Reporting System (CALFIRS).

- i. Once completed, will start compiling data for 2023 Redbook.
- b. In the process of hiring new Research Data Analyst for the program. Will be the first for the program.
- c. Continuing to work closely with Fire Research Safety Institute (FSRI) and US Fire Administration in the development of the National Emergency Response & Information System (NERIS) that will replace the National Incident Reporting System (NFIRS) in 2025.

ii. Community Wildfire Mitigation Assistance

- 1. Land Use Planning
 - a. Ongoing work with local jurisdictions on Safety Elements and support Wildland Urban Interface (WUI) requirements.

2. National Fire Protection Association Firewise USA

- a. As of last week, we currently have 800 communities in "good standing".
- b. Early stages of recognizing the community in Ventura County with other local agencies mid-May.
- c. New applications come in weekly.
- d. Staff work with those communities through the application process.

3. Subdivision Review

- a. Continue working throughout the State with jurisdictions on identification of subdivisions meeting the PRC 4209.5 criteria.
- b. April PRC: presented 59 Fire Safety Survey from City of Avalon, Shasta, and Trinity Counties.

4. Local Planner Training

- a. Tahoe City April 25, Redding April 30 Posted: Community Wildfire Planning Center
- b. Target audience for this class: local planners, building officials and fire marshals.
- c. Class provides and understanding of California state requirements for land use planning in fire hazard areas, including the General Plan Safety Element, Fire Safe Regulations, Subdivision Review Program, and applicable chapters of California Building and Fire Codes.
- d. Benefit: Interact with peers to exchange perspectives on fire mitigation and planning through exercises and facilitated discussions.

5. Wildfire Prevention Grants Program

- a. FY 2023-24 Wildfire Prevention Grants are in the region review process.
- b. Received 224 applications requesting \$254.2M in funding
