    - 1. Defensible Space
      - a. Statewide SRA Total for Fiscal Year-to Date 2023-2024:
        - i. 230,226 inspections completed, 92% of the goal 250,000 goal.
        - ii. Statewide Qualified Entity training coordination is continuing.
          - Next class starts May 31 for Nevada, Yuba, and Placer counties.
    - 2. Burn Permits
      - a. 85,214 requested 78,614 issued.
      - b. 129,718 issued since the January 3, 2023 launch.
    - 3. Home Hardening
      - a. Our first home has begun construction in LNU.
      - b. A Home Hardening video campaign has begun to inform the public of the steps to take to retro fit your home.
    - 4. Utility Wildfire Mitigation Program

- a. The Wildfire Mitigation Plan Updates (WMPs) are in review for PG&E, SCE, BVES, SDG&E and are planned to have draft decisions published on 7/2/24, pending any revision notices.
- b. Continued training for CAL FIRE Defensible Space Inspectors for PRC 4292 & 4293 compliance inspection.
- Utilities will be conducting their PSPS exercises over the next few months.

  - 1. Fuel Reduction Projects
    - a. 687 projects, 137% of the goal
  - 2. Combined Fuel Reduction
    - a. 69,729.9 acres treated, 69.7% of the goal
      - i. Unit Projects 32,545.9 acres
        - 1. Northern Region: 21,057.8 acres
        - 2. Southern Region: 11,488.1 acres
    - b. Grant Projects: 31,838.4 acres
    - c. CFIP Projects: 5,345.6 acres
  - 3. Prescribed Fire (also counted in fuel reduction)
    - a. 21,887.4 acres treated, 43.8% of the goal
  - 6. Wildlands Fuels Reduction Reporting
    - a. Development of the CalMAPPER V4 continues.
      - i. Meeting with vendor to develop data collection for fuel model adjustments.
    - b. Working with Task Force Monitoring Reporting and Assessment workgroup to develop a planned acre reporting process

    - c. May 6, 2024 New NERIS Core Data Public Schemas were released (NERIS Core Data Schemas released in Beta [fsri.org])
      - i. Released in three forms: an Executive Guide (for all fire service leaders, firefighters, and other non-technical stakeholders), General Release (for data analysts), and a Technical Release (for software developers, engineers, and technical support teams).
- ii. Community Wildfire Mitigation Assistance

- 1. Land Use Planning
  - a. Work continues statewide with numerous jurisdictions on Safety Element of General Plan
  - b. City of Irwindale Safety Element was presented at RPC meeting earlier this month
- 2. National Fire Protection Association Firewise USA
  - a. Celebration of 800<sup>th</sup> community in good standing was held on 5/18/24
    - i. Ken Crest Ridge community in Ventura County
  - b. 847 communities in good standing. Several NEW applications in the portal each week
- 3. Land Use Planning for Wildfires Course
  - Final classes of the spring were recently held in Santa Barbara and Sacramento
  - b. Next steps will be continuation of these classes late this year or early next year
  - c. Looking at options for spin-offs of this course
- 4. Subdivision Review
  - a. Currently working with Modoc and Sierra Counties
- 5. Wildfire Prevention Grants Program
  - a. Sacramento review in late May
  - b. Grantee announcements in July

- i. California Wildfire Mitigation Program Authority Update
  - 1. Budget Hearings
  - 2. Response to current proposed bills SB-946, AB-2469, AB-2983
- ii. Demonstration Communities
  - Shasta County FSC/Shasta Co:
    - a. Finalizing Tri-party and Master Agreements
    - b. Will include prevailing wage
    - c. Submitted five issue property packets to FEMA. Waiting for Biological Analysis
  - 2. San Diego County Fire Dept./San Diego Co:
    - a. Final revised contractor quote \$71,338.50 (original \$87,084.23) includes home hardening and hardscaping
    - b. Vegetation management work is complete and costs from the CCCs came in approximately half of the original quote

- c. SDCFPD re-opened the RFQ for qualified contractors. RFQ is now closed, and one additional C-47 contractor has expressed interest
- d. SDCFPD is working on updating insurance requirements in Master Agreement to encourage more participation
- 3. Tuolumne Co:
  - a. EHP Phase I deliverables were submitted to FEMA for review
  - b. FEMA returned deliverables with feedback for corrections
  - c. Initial community meeting conducted April 25, 2024
- 4. El Dorado Co:
  - a. EHP Phase I intent to award has been issued
  - b. Award requires County Board of Supervisors approval
  - c. Program positions have been approved by the Board
  - d. Full time equivalent positions supporting the program
- 5. Shasta Valley RCD/Siskiyou County:
  - a. The Tri-party agreement is complete
  - b. Will be able to begin work once bids are received and awarded
  - c. Expected scheduling contractor walk-throughs early June
- 6. North Coast Opportunities/Lake Co:
  - a. Wildfire home hardening and defensible space work is underway
  - b. Nesting bird remains on property
  - c. Next home is expected to begin work in early June
  - d. Following two homes in mid-June
  - e. New home assessors are continuing to develop capacity
