The meeting was called to order at 1:00 PM by Daniel Berlant.

- B. Roll Call Carrie Lewis
  A quorum was not established with 10 committee members present in-person and eight attending virtually.

  - i. Wildfire Preparedness
    - 1. Defensible Space
      - a. Statewide SRA Total for Fiscal Year 2023-2024:
        - i. 185,077 inspections completed, 74% of the goal (250,000 Goal)
      - b. Burn Permits
        - i. 49,382 requested 44,931 issued
        - ii. 96,033 issued since the January 3, 2023 launch.
    - 2. Home Hardening
      - a. Collaboration with CalOES is ongoing for the California Wildfire Mitigation Program including the preparation for work to begin on the first structure to be retrofitted by North Coast Opportunities in Lake County.
      - b. Conducted the classroom portion of the CWMP DSI/HIZ training for the Shasta and North Coast Opportunities personnel. Field days are scheduled for 3/20 in Shasta and 3/21 in Lake County.
    - 3. Utility Wildfire Mitigation Program
      - a. Continuing to review and update the Powerline Field Guild.
      - b. PRC 4292/4293 statistical data sampling review is continuing.
      - c. Collaboration with Power Pros to assist with the training on curriculum on powerline identification, safety, and PRC 4292/4293.
  - i. Wildfire Planning and Statistics
    - 1. Fuel Reduction Projects
      - a. 570 projects, 114% of the goal

  - a. 54,946.9 acres treated, 54.9% of the goal

  - a. 22,054.8 acres treated, 44.1% of the goal

- ii. Community Wildfire Mitigation Assistance
  - 1. Land Use Planning
    - a. Ongoing work with local jurisdictions on Safety Elements and Subdivision review (SDR) program
      - At this month's Resource Protection Committee (RPC) meeting, El Dorado County Safety Element and Marin County SDR surveys were presented to the Board.
      - ii. Currently submitted for Board review: City of Monterey, City of Chula Vista, and the City of Irvine.
  - 2. National Fire Protection Association Firewise USA
    - a. Staff continue to provide communities assistance throughout the state with the application process.
    - b. Currently 790 communities in good standing.
    - c. Staff currently working on over 50 new applications.
    - d. 800th community to be determined soon.
  - 3. Subdivision Review
    - a. Staff continue doing fire safety surveys throughout the state as jurisdictions assist with local identification.
    - b. Current fire safety survey areas: San Bernadino, Ventura, Inyo, Mono, Plumas, Sierra, Shasta, Siskiyou, and Modoc counties.
    - c. Once completed, these surveys will be presented at the closest month RPC meeting.
  - 4. Local Planner Training
    - a. Introduction to Land Use Planning for Wildfires in California course
      - i. Registration now open for at least 4 more training dates in 2024
      - ii. Register at www.communitywildfire.org/trainings
      - iii. Trainings held recently on 3/12 in Santa Rosa and on 3/14 in Morgan Hill

- iv. Next class will be Tahoe City on 4/25 and Redding on 4/30
- 5. Wildfire Prevention Grants Program
  - a. FY 2023-24 Wildfire Prevention Grants Solicitation closed on January 10, 2024
  - b. We received 224 applications requesting \$254.2M in funding
  - c. Announcements are expected summer of 2024
- B. California Wildfire Mitigation Program (CWMP) Report
  - i. North Coast Opportunities (NCO) in Lake County:
    - 1. FEMA Award: 3/17/2023, Revised Award: 8/15/23
    - 2. First property received 7 bids' 4 D space only; 3 are comprehensive Home hardening and D Space
    - 3. The winning bid is \$34,000
    - 4. Comprehensive bids ranged from \$31-100K
    - 5. NCO is bringing on three new property assessors
    - 6. Assessor training class scheduled for March 14-21
  - ii. Shasta County Fire Safe Council (FSC)
    - First Property (CWMPA-000033) has received three quotes ranging from \$46-58K
    - 2. Three current assessors on staff. Three more to be trained in upcoming Assessor Training scheduled for March 15-20.
  - iii. San Diego County Fire Department
    - 1. FEMA Award: 8/29/23
    - 2. Out of eight SOW, four SOW went to EHP Phase II review assessor training.
    - 3. One current assessor on staff. Additional staff trained in February
    - 4. Seven County Prevention Specialists (will be assisting with assessments)
    - 5. Five County Building Inspectors for permitting purposes
    - 6. Three San Diego Fire Department personnel (observers)
  - iv. Tuolumne County
    - 1. FEMA Award: 6/22/23
    - 2. Phase I work with FEMA for the previous projects (Shasta, Lake, and San Diego) streamlines the FEMA approval process. The new process and lessons learned are expected to expedite the completion of Phase I for Tuolumne County.
    - 3. Phase I EHP vendor has been working on EHP Phase I deliverables since mid-December
      - a. SMEs met with FEMA on February 7
      - b. EHP Phase I is proceeding as expected
      - c. EHP Phase I is expected to take 6-9 months from the beginning of SME work
    - 4. Community update will be provided by county staff, CWMP, and CAL FIRE in April

- v. El Dorado County
  - 1. FEMA Award: 6/29/23
  - 2. Phase I work with FEMA for the previous projects (Shasta, Lake, and San Diego) streamlines the FEMA approval process. The new process and lessons learned are expected to expedite the completion of Phase I for El Dorado County.
  - 3. The county is reviewing bids and will choose a winning vendor this month
