<u>1) Purpose</u>

The Wildfire Mitigation Advisory Committee (Committee) will provide a means of communication between the CAL FIRE-Office of the State Fire Marshal, representatives of industry, state agencies, the fire service, and other stakeholders. The Committee will provide a forum for addressing wildfire preparedness and mitigation issues of statewide concern, share best practices, seek comments and specific input on programs and technical issues, and inform local agencies and the public of applicable new laws and regulations.

2) Goals and Objectives

The Committee is being formed pursuant to Assembly Bill 9 (Chapter 225, Statutes of 2021) to act in an advisory capacity on the programs and activities of the Community Wildfire Preparedness and Mitigation Division.

Goal:

Professional, effective, and consistent delivery of the programs and activities of the Community Wildfire Preparedness and Mitigation Division.

Objectives:

- Provide a consistent and regular means of communication on topics related to community wildfire preparedness and fire mitigation between the department, the Office of the State Fire Marshal, representatives of relevant industries, state agencies, fire service agencies, and other stakeholders
- Provide a forum for addressing wildfire preparedness and mitigation issues of statewide concern
- Share latest available research and best practices with regard to community fire preparedness and mitigation efforts
- Seek and provide comments and specific input on proposed programs, policies, guidelines, budget, and technical issues, and inform local agencies and the public of applicable new laws and regulations
- Provide and receive updates and feedback regarding the programs operated by the Community Wildfire Preparedness and Mitigation Division within the Office of the State Fire Marshal



3) Committee Membership

Members of the Committee shall be all of the following:

- The Director of the Department of Forestry and Fire Protection, or their designee
- The Director of the Department of Conservation, or their designee
- The Director of the Office of Energy Infrastructure Safety, or their designee
- The chair of the State Board of Forestry and Fire Protection, or their designee
- The State Fire Marshal, or their designee
- The Director of Emergency Services, or their designee
- The Insurance Commissioner, or their designee
- The Director of State Planning and Research, or their designee
- A representative from the California Fire Safe Council
- A representative from the insurance industry or an insurance research organization

The State Fire Marshal may decide to add any other appropriate stakeholders, including representatives from local governmental agencies.

The chairperson of the Committee shall be the State Fire Marshal.

The members of the Committee shall serve without compensation, but each member shall be reimbursed for their actual and necessary expenses incurred in the performance of their duties.



4) Meetings

Schedule

• The Committee shall meet on the third Tuesday of each month. If the meeting lands on a holiday, the Committee shall postpone and meet on the subsequent Tuesday.

Location

- Meetings shall be regularly scheduled in Sacramento
- Meetings may be scheduled throughout the state on an as-needed basis

Meetings will not be cancelled without cause

In order to ensure consistency and transparency, the following Roberts Rules of Order shall be adhered to:

- An approved published agenda,
- Meeting minutes,
- A quorum,
- Motions and seconds, and
- Voting requirements (including requests for roll call voting).

Rules for recognition and timelines for debate will be suspended unless specifically enacted by the membership.

Meetings may be rescheduled if the Committee is unable to meet a quorum.

A motion will be passed by a simple majority of the entire voting membership.

All members, voting and non-voting, may submit informational, discussion, and/or action items for the agenda prior to the meeting. Agenda items will take precedent and non-agenda items may be transacted upon if time permits.



5) Committee Protocol

The Committee shall comply with Bagley-Keene Open Meeting Act

- Only items listed on the published agenda as "Motion Required" may be acted upon
- The Committee chair has the authority to set time limits on any agenda item

<u>6) Process</u>

- The Community Wildfire Preparedness and Mitigation Division will provide administrative support to the Committee
- Agenda items should be submitted to the Committee coordinator four weeks before the scheduled meeting date
- Minutes will be taken at each meeting that capture the essence and actions of the meeting
- Draft minutes will be posted on the Office of the State Fire Marshal website for review by the Committee and other interested parties
- After approval at the next meeting, final minutes will be posted on the Office of the State Fire Marshal website



<u>7) Quorum</u>

• A simple majority (50% plus 1) of the committee membership shall be a quorum.

8) Responsibility of the Chair

• Interpretation and decisions are the purview of the chair.






Wildfire Planning and Risk Reduction

• Wildfire Preparedness

- Wildfire Preparedness processes reduce or eliminate fire hazards and risks, and change the environment by removing or reducing the heat source, modifying or reducing the fuels (this is where our defensible space program resides), and modifying the act or omission allowing the heat source to contact ignitable fuels.
- Part of CAL FIRE's mission is to prevent fires and protect habitable structures within the State Responsibility Area (SRA). Other important activities include defensible space inspections, home hardening, emergency evacuation planning, fire prevention education, fire hazard severity mapping, implementation of the Strategic Fire Plan for California, fire-related law enforcement activities such as investigations to determine fire cause and origin as well as arson cases, and support for local government fire safe planning in the SRA.



Wildfire Planning and Risk Reduction

- Utility Wildfire Mitigation
 - The Utility Wildfire Mitigation program was created in the fall of 2018 as a result of State legislation focused on climate change and powerline utility caused fires (reference Senate Bills 1028 and 901).
 - CAL FIRE subject matter experts and other agencies conduct comprehensive reviews of the Utility Wildfire Mitigation Plans annually.





Wildfire Planning and Statistics

• Pre-Fire Planning

- The continued inclusive collaboration among local, state, federal, tribal, and private partners remains paramount to effectively manage towards a more fire resilient wildland urban interface and natural environment. The Plan construes "collaboration" very broadly, from working together to implement a single fuel break, working together to develop a Community Wildfire Protection Plan, to developing and administering the statewide, multiagency California Fire Management Agreement.
- The Pre-Fire Planning program forms the basis for assessing California's complex and dynamic natural and built environments, and they identify a variety of actions to minimize the negative effects and enhance the positive effects of fire.



Wildfire Planning and Statistics

California Incident Data & Statistics

- CalStats is a statewide emergency incident data collection program that analyzes and distributes statistical information reported by fire departments throughout the state.
- CalStats complies with Health and Safety Code 13110.5 to provide fire data and information to the fire community, and as a resource for the public. The data collected by CalStats includes such information as numbers of fires, causes of fires, types of fires, and locations of fires.





Community Assistance

• Wildfire Mitigation Advisory Committee

- The Committee is being formed pursuant to Assembly Bill 9 (Chapter 225, Statutes of 2021) to act in an advisory capacity on the programs and activities of the Community Wildfire Preparedness and Mitigation Division.

Community Wildfire Mitigation Assistance Program

• Land Use Planning

- CAL FIRE's Land Use Planning program assists local governments (cities and counties) throughout California as they address the unreasonable risk from wildfire by planning for new development in the State Responsibility Areas and Very High Fire Hazard Severity Zones.
- This program also assists communities in becoming Firewise USA[®] recognized communities to help in reducing the risk of wildfire.





Community Wildfire Mitigation Assistance Program

- Wildfire Prevention Grants
 - CAL FIRE's Wildfire Prevention Grants Program provides funding for fire prevention projects and activities in or near fire threatened communities that focus on increasing the protection of people, structures, and communities.
 - Funded activities include hazardous fuel reduction, wildfire prevention planning, and wildfire prevention education with an emphasis on improving public health and safety while reducing greenhouse gas emissions.





Risk Modeling

• AB642

- SEC. 10. Section 4204.1 is added to the Public Resources Code, to read:
 - 4204.1. (a) On or before July 1, 2023, the department, in consultation with the State Fire Marshal and the Insurance Commissioner, shall make recommendations on how to understand and model wildfire risk for a community and specific parcels within the local responsibility area or state responsibility area through the input of mitigating factors.
 - The department's recommendations shall include all of the following:
 - (1) Identification of mitigation factors that must be included to determine risk.
 - (2) Cost-effective ways to gather data on mitigation factors.
 - (3) A discussion on how parcels can affect the risk of other parcels in close proximity.
 - (4) An evaluation of the effectiveness of using natural infrastructure as a community buffer.
 - (5) A review of other jurisdictions' applicable wildfire risk models.
 - (6) Identification of barriers to determining the wildfire risk of a community and specific parcels.
 - (b) (1) The department shall establish, and consult with, an advisory workgroup to develop the recommendations required pursuant to subdivision (a).
 - (2) The advisory workgroup established pursuant to paragraph (1) shall include all of the following members:
 - (A) The State Fire Marshal, or the State Fire Marshal's designee.
 - (B) The Director of Emergency Services, or the director's designee.
 - (C) The Insurance Commissioner, or the Insurance Commissioner's designee.
 - (D) The Director of State Planning and Research, or the director's designee.
 - (E) The Director of Housing and Community Development, or the director's designee.

Risk Modeling

• AB642

- (F) Two representatives from insurers and insurance research organizations that have appropriate expertise in wildfire risk modeling, such as exposure measurement, risk modeling, and actuarial expertise, to be appointed by the department.
- (G) Two representatives, one a fire chief, or the fire chief's designee, and the other a fire prevention officer, to be appointed by the department in consultation with the California Fire Chiefs Association and the Fire Districts Association of California.
- (H) A representative from the California Professional Firefighters, to be appointed by the department.
- (I) A representative from the California Fire Science Consortium, to be appointed by the department.
- (J) A representative from the California Building Industry Association, to be appointed by the department.
- (K) Two representatives from a local government, with one from a rural city or county, to be appointed by the department.
- (3) The appointed members of the advisory workgroup shall serve at the pleasure of the department.
- (4) The members of the advisory workgroup shall serve without compensation, but each member shall be reimbursed for their actual and necessary expenses incurred in the performance of their duties.
- (5) The chairperson of the advisory workgroup shall be the State Fire Marshal, or the State Fire Marshal's designee.
- (6) The vice chairperson of the advisory workgroup shall be the fire chief specified in subparagraph (F) of paragraph (2), or the fire chief's designee.
- (c) The department shall post the recommendations required by subdivision (a) on the department's internet website.
- (d) This section shall remain in effect only until January 1, 2025, and as of that date is repealed.
