- B. Division Report -
 - 1. Community Wildfire Mitigation Assistance
 - Firewise:
 - California continues to lead the nation with 680 National Fire Protection Association (NFPA) Firewise USA Communities in good standing.
 - Continuing to equate to over 30% of all NFPA Firewise USA Communities nationwide.
 - Wildfire Prevention Grants:
 - Received nearly 250 applications totaling approximately \$400 million.
 - FY 22-23 Grant Awards to be announced in early July.
 - Land Use Planning:
 - Final class for this year scheduled in Sacramento on May 17, 2023.

- 2. Wildfire Planning and Statistics -
 - California Incident Data & Statistics Program:
 - Fire Hazard Severity Zone (FHSZ) public comment period closed April 4, 2023.
 - Currently reviewing over 1000 public comments received.
 - Developing a Community Wildfire Protection Plan (CWPP) tool kit and updated website to assist local jurisdictions and community organizations with CWPP development.
 - Fuel Reduction Projects:
 - 443 projects, 88% of the goal
 - Combined Fuel Reduction:
 - 47,594 acres treated, 47% of the goal.
 - Unit Projects 26,792 acres
 - Grant Projects 20,802 acres
 - Prescribed Fire (also counted in fuel reduction):
 - 20,501 acres treated, 77% of the goal.
- 3. Wildfire Preparedness
 - Defensible Space Inspections:
 - 194,105 inspections, 77% of the goal.
 - Burn Permits:
 - Every year on May 1st and thereafter, you must apply for a new burn permit.

 - Utility Wildfire Mitigation:
 - Participated in the CPUC Joint Investor-Owned Utility (IOU) PSPS post season workshop on April 19th.
 - The IOUs presented on last year's PSPS events, lessons learned, any improvements in forecasting, notifications, communications, and interactions between PSPS and Fast trip.
