- B. Division Report
 - i. Wildfire Planning and Statistics -
 - 1. Fire Hazard Severity Zones:
 - a. Third FHSZ SRA comment period has concluded, and all comments are being evaluated.
 - b. www.osfm.fire.ca.gov/fhsz
 - 2. Fuel Reduction Projects:
 - a. 93 projects, 18.6% of the goal
 - 3. Combined Fuel Reduction:
 - a. 1,683.4 acres treated, 1.7% of the goal.
 - b. Unit Projects 1,671.7 acres
 - i. Northern Region: 1,485.6 acres
 - ii. Southern Region: 186.1 acres
 - c. CFIP Projects: 11.7 acres

- 4. Prescribed Fire (also counted in fuel reduction):
 - a. 1,184.3 acres treated, 2.4% of the goal.

ii. Wildfire Preparedness -

- 1. Defensible Space:
 - a. Statewide SRA Total:
 - i. 36,272 inspections, 15% of the goal (250,000)

2. Burn Permits:

- a. Working closely with Air Districts to clarify burn permit language. This helps the public with accurate information and helps our partnership with the Air Districts.
- b. Any changes will ensure the Department's requirements are met while doing our best to accommodate other agencies.

iii. Community Wildfire Mitigation Assistance -

- 1. Local Planner Training:
 - a. Work continues on updating the Local Planner Training.
 - i. 10-14 additional dates in Spring and Fall 2024.

2. Firewise:

- a. Currently 704 communities in good standing.
- b. 9 new applications awaiting approval.
- c. 700th Firewise Community Upper Mark West Springs Community in Sonoma County.
- d. The community event was held on August 12, 2023, and our team provided a certificate of recognition as the 700th community along with the NFPA Firewise USA Community signs.

3. Subdivision Review (SDR):

- a. Fire Safety Surveys:
 - Staff continue to survey various jurisdictions throughout Statewide with the collaboration from local agencies when feasible.
 - ii. To date: 1,515 Fire Safety Surveys have been approved by the Board of Forestry (BOF).

4. Wildfire Prevention Grants:

- a. First year we had a full digital process for solicitation, 248 apps for \$400 million. \$113 million available to disperse.
- b. On July 27, 2023, WP Grants announced 96 awards for \$113 Million in funding.
- c. Governor's Office provided the Communications Press Release on July 28, 2023.
- d. State Senate and Assembly members were notified on August 02, 2023, of the awards in their respective districts.

- A. J. Lopez (Board of Forestry and Fire Protection):
 - i. An update on the California Wildfire Mitigation Program:
 - 1. Tuolumne County and El Dorado County got their phase one approval.
 - 2. San Diego and Lake County are both in the last portion of their loan project and funding it moving along.
 - 3. More projects are in the future, and we are now managing 95 million dollars.

 - i. Working on Fall planning for local burns in the Butte Plumas area.
 - ii. Local efforts are being held in the Butte County and Plumas regarding prescribed fire.
- C. Catherine Freeman (California State Association of Counties):
 - i. Holding a webinar on Thursday, August 17th with Alex Padilla on best practices for evacuations in wildfires.
- D. Clay Kerchof (Department of Housing and Community Development):
 - i. On August 14th, the Department of Housing and Community Development submitted its 2020 and 2021 Action Plan Amendment 3. This action plan incorporates Community Development Block Grant for Disaster recovery funds that HUD allocated to the State of California for 2021 wildfires. This funding is in response to DR 4610, and we are directing all of the \$24.4 million allocation to long term recovery in Plumas County. There was a 40day public comment period. Look forward to having grant agreement signed in the late Fall.
- E. Yana Valachovic (California Fire Science Consortium):
 - i. New coordinator has started and has put out a new webinar in the last week.
- F. Lenya Quinn-Davidson (University of California Cooperative Extension):
 - i. Currently hiring a Fire Advisor for Humboldt/Del Norte to backfill her position.
- G. Roy Wright (Insurance Institute for Business & Home Safety):
 - Working with California Department of Insurance and Cal FIRE on a Defensible Space demo that will be scheduled in September.
- H. Jacy Hyde (California Fire Safe Council):
 - i. Held a Listos CalOES Workshop Partnership event on August 15th.
- I. Michael Maguire (Office of Planning and Research):
 - i. Funding for round three for the Wood Feedstock Pilot Project.
- J. Caroling Thomas Jacobs (Office of Energy Infrastructure Safety):
 - i. Will be rolling out the Wildfire Mitigation Plan results in the next couple of months.
