Safe and Sane Booths



What if you find an item that is not on a company's list?

- Step No.1: Check each of the other company listing's to make sure it is not a firework item that is distributed by another company which this particular company may have contracted to distribute.
- Step No. 2: If the item does not appear on any company's list, call the contact person for the fireworks company who is the supplier for that particular stand (Please refer to enclosed list for contact names and phone numbers). Most fireworks companies maintain a 24-hour toll free number.
- Step No. 3: If you are still unable to resolve your questions or are still concerned about whether the item in question has been classified by the Office of the State Fire Marshal as Safe and Sane, contact our Fire Engineering Division's Fireworks Program staff at (916) 568-2943 for assistance. If it is determined that the item has not been classified by the Office of the State Fire Marshal as Safe and Sane, then it should be confiscated and removed from the stand.



Snap Caps and Party Poppers

- ► Classified as pyrotechnic device, not fireworks
- ► Are legal for year-round sales throughout California, unless there is a local ordinance restricting the sale.
- ► Must still be registered





Snap Caps and Party Poppers

Does NOT include Adult Snaps or similar fuseless firecrackers

Broadened Fireworks
Disposal Management by
OSFM in HSC 12726,
specifically mentioning
OSFM Arson and Bomb
Unit Operations

Fines were doubled within HSC 12700

Further defined OSFM training to local fire and law enforcement agencies within HSC 12726.1

Further codified training and education in accordance with Title 19 and NFPA Standards:

495: Explosive Materials Code of 2013.

1124: Code for the
Manufacture,
Transportation, Storage,
and Retail Sales of
Fireworks and Pyrotechnic
Articles of 2013.




Examples of Illegal Fireworks and Explosives

- Metal Sparklers
- Skyrockets
- Bottle rockets
- •Roman candles
- Aerial shells
- •Firecrackers
- •Other fireworks that explode, go into the air, or move on the ground in an uncontrollable manner

It is illegal to sell, transport, or use fireworks that do not carry the "Safe and Sane" seal, and it is illegal to possess or use any fireworks in a community where they are not permitted.

- Safe and Sane Fireworks modified or not used properly increases the risks
- Consumer Fireworks that do not meet the Safe and Sane Standard and are illegally transported into and used in California severely increase the risks
- Increased misuse of Illegal fireworks during protests, civil disobedience, and riots increases the risks
- Year-round Illegal online sales and delivery methods continue to increase the risk
- The involvement of gangs and organized crime in black market sales further increases the risks
- Fireworks have been directly linked to the manufacturing of illegal explosives and acts of terrorism, increasing the risks

California's Unique Fuel, Weather, and Topography Put the State At Continued Risk of Wildfires



Why is this important?



- Burn injuries continue to be a leading cause of accidental death and injury in the United States
- Even legal fireworks can be dangerous
- Long term effects: scarring, life-long disabilities, life altering adjustments





Firework National Statistics



- In 2022, there was an estimated 10,200 injuries
- Trends show that there is an increase in 535 injuries each year since 2007



Firework National Statistics


- From June 17, 2022 July 17, 2022, there were a total of 7,400 injuries treated in the ED
- Males account for 65% of the injuries
- More than half of the injuries are people under the age of 25
- For children under the age of 5, sparklers account for 29% of the firework injuries for that age group

Local Statistics (Northern CA)


- In 2023, Sacramento Metro Fire responded to approximately 130 fires and multiple burn victims
- UCDMC Emergency Department Consults:
 - 2020: 3
 - 2021: 5
 - 2022: 2
 - 2023: 6
- Inpatient Consults
 - 2020: 0
 - 2021: 3
 - 2022: 1
 - 2023: 3
- Shriner's Children's Hospital:
 - 33 cases in the last 10 years
 - Average age 10 years old
 - Mostly 3rd degree





Firework Safety Tips

- Children should never handle or use fireworks at anytime, Sparklers can reach up to 1200 degrees
- Consider using safer options such as glow sticks, confetti poppers and streamers
- Children should always be kept a safe distance away





Firework Safety Tips

- Fireworks should always be used outdoors
- Read the caution labels
- Do not attempt to alter fireworks
- Keep a hose and/or bucket readily available
- Do not attempt to relight a "dud firework"
- Soak all fireworks overnight in water in a metal container
- Never hold, point or throw fireworks at another person








Leave the show to the Pros



If you do get burned...



- Cool the burn under cool running water for 20 minutes
- If the burn is the size of their hand, seek treatment immediately
- Do not apply any topical creams or ointments
- Seek treatment when in doubt
