A. Stephan Smith NFPA Single Exit Symposium round table discussion

- i. Jeff Maddox Cost impact second stair upward \$228k.
  - 1. Stephen Smith Vertical construction, stairs, standpipe. Stairs take up 6-7% of floor area and cost being 10% seems correct.
  - 2. Jeff Maddox This group may need more research to cost impact. Elevator considerations for secondary egress. Cost plug/play pressurization vs exhaust systems for this use.
  - 3. Ali Fattah Not so common in Seattle as disclosed in the presentation. There needs to be a more standardized approach to this so we all on common ground. Pressurization vs exhaust systems reports need to more reflective of the construction methods in the US.
  - Kyle Krause It is very difficult for officials to justify reducing the level
    of safety because of cost. HCD vs SFM authority. HCD has limited
    statutory authority and path forward what the co-adoption would look
    like.
