3. NEW BUSINESS Sujeski

- A. Sub-Groups Report
 - a. AB 2322 CH7A ASCE 7 Sub-Group Paul Armstrong <u>parmstrong@awc.org</u> and Sunup Matthew <u>smathew@imiweb.org</u> (reported)
 - i. The group is meeting twice or bi-weekly

- ii. Structures are being reviewed under Risk Categories 3 and 4. These are typically considered critical infrastructure such as fire stations, police station, hospitals, etc. The goal is to provide provisions to protect critical infrastructure from wildfire.
 - 1. Review is based on:
 - a. ASC 7 (ASCE 7 Minimum Design Loads)
 - b. California Building Code
- iii. The team is close to completing the identification of structures to be included or excluded.
- iv. Spreadsheet/Table is being used to track review status and decisions:
 - 1. Red: Agreed not to include in the proposed provisions.
 - 2. Green: Agreed to include in the proposed provisions (with some edits/additions).
 - 3. Yellow: Need more discussion before a decision can be made.
- v. Terminology is being discussed to use to reference the identified structures vs Risk Categories 3 and 4.
- vi. Applicable to SRA and LRA
- vii. FHSZ Level of Protection: ½ hour Moderate, 3 hour High, 4 hour Very High

 - ii. 501.1 vs 101.3.1 Exceptions for Group U
 - 1. Need to verify the location to confirm intent and prevent redundancy.
 - 2. Coordinate/Collaborate with Scope Sub-workgroup.
 - iii. 504.11 Miscellaneous structures and accessory buildings, and applicable buildings.
 - 1. Unenclosed vs enclosed structures
 - 2. Projection and Deck Requirements
 - 3. Setbacks and separation distance of structures on adjacent property to eliminate fire spread from structure to structure.
 - iv. ICC WUI27 Proposal language may be helpful

 - i. Vents to be considered
 - Covered Vent Types:
 - a. Attic and rafter vents.
 - b. Underfloor vents.
 - 2. Other ventilation openings (for unoccupiable spaces like garages, mechanical rooms).
 - 3. Exempted Vent Types:
 - a. Exhaust openings such as:
 - b. Dryer vents
 - c. Kitchen and bathroom exhausts
 - d. Drain/waste vents
 - e. Direct vent appliances

- ii. Testing and Compliance
 - 1. Be approved by the State Fire Marshal or tested under ASTM E2886, and meet specified pass/fail criteria.
 - 2. (For vents excluded from ASTM E2886, like roof ridge/off-ridge field vents) Meet alternative material and design standards:
 - a. Openings ≤ 1/8 inch
 - b. Made of non-combustible, corrosion-resistant materials
- iii. Distance & Placement
 - 1. Add Non-tested vents must not be within 10 feet of property lines. Does not apply to tested and approved vents
 - 2. Underfloor vents previously required to be "as close to grade as practical" this language was removed due to fire and flood concerns, and updated understanding from IBHS testing.
- iv. Ventilations Opening Definitions vs commentary with or without pictures to clarify.
- v. Weathering Test requirements to be considered. Further research needed
