3. NEW BUSINESS

Robert Marshall

- A. Subgroups
 - i. Cost Impact [Lead Stephen Smith] stephen@centerforbuilding.org
 - 1. Stair Cost – Estimate 7.5-10% of total cost. ([Cost Report](#))
 - a. Single Stair buildings will have a higher per square foot cost
 - i. Elevator
 - ii. Fascade
 - b. Cost of corridor (Jeff Maddox)
 - c. Returns (change in rents), not just dollar costs; relative to other building types (Ed Mendoza)
 - d. Prototypes, one vs. two stairs for same small building (Ali Fattah)
 - e. Affordable to who? Vacancy chains (filtering), area median income % (Robert Marshall)
 - f. Elevator costs (Crystal Sujeski)
 - g. Exterior stair – costs, problems (James Dobson)
 - ii. Fire Protection (Active/Passive) [Lead Jeff Maddox] jmaddox@thefireconsultants.com
 - 1. Smoke Control – Focused on reliability for use and FD operations.
 - a. Stairway Opening are maintained. Use of electronic mg hold opens to reduce door propping.
 - b. Prohibit electrical receptacles to prevent the storage and charging of e-mobility devices in the stairway.
 - c. Require a 4 square foot smoke vent shaft to relive smoke pressure out the corridor (if any corridor is provided)

- d. Exterior stair or stair with enough exterior opening to vent smoke.
 - 2. Fire Alarm
 - a. R-2 Building – Keep standard code requirements for R-2.
 - i. Should we take away the exception to remove manual pulls. (R Marshall)
 - b. Stairway – Electronic hold open devices
 - c. Voice Notification – Common Space
 - d. Smoke detection vs. Smoke alarms
 - 3. Sprinkler System
 - a. R-2 Building – fully sprinklered (13 or 13R as permitted)
 - i. Stairs open to units on multi level should require sprinklers on all levels. (R Marshall)
 - b. Secondary Water Supply – Tank/street Connection are not necessary but there was discussion of requiring a second redundant riser.
 - c. In California, sprinklers are mandatory
 - i. What about repurposing of non-sprinklered buildings?
 - ii. ADUs are currently not required by law
 - 4. Types of Construction/Building Height
 - a. Single Exit Stair building up to 4-7 stories, but below the high-rise threshold.
 - i. Concern with earthquake damage impacts to single stair reliability.
 - 5. Rescue Windows – Determined to be outside the sub work group realm. But we recommend the Work Group research.

 - 1. What are other states/larger/small cities doing?
 - a. Key Variables
 - i. Number of stories 4, 6, high-rise
 - ii. Number of dwelling units per story
 - iii. Allowable building area per story
 - iv. Direct access to a stairways or through the intermediate corridor
 - v. Emergency escape and rescue opening are required/fronting in a public way.
 - vi. NFPA 13 fire sprinkler system
 - vii. Non-combustible constriction
 - viii. Smoke-proof exit enclosure
 - ix. Pressurization of elevator hoist ways
 - b. Not Addressed
 - i. Maximum height in feet
 - ii. Local condition modifiers due to seismic, flood, winds
 - iii. Responding fire department capabilities
 - iv. Increase protection of the unit allow self-preservation in the event of delayed response and loss of single exit.
 - v. Increase stairway width
 - vi. Two-way communication

- c. Conclusion
 - i. Focus on US jurisdictions due to variability in codes, firefighting capabilities, and tactics.
 - ii. Commonality of number of units per story, the type of fire sprinkler system required, and the number of sorties minimum 4 to maximum of 6.
 - iii. None allow high-rise
 - iv. Rely on base code for type of construction, fire alarm, means of egress requirements.

 - 1. Firefighting Capabilities –
 - a. Creating Survey to collect data – Firefighting capabilities (Firefighter access, firefighting tactics, and Fire Equipment needs (aerial apparatus).
 - b. Spoke to Cal Chiefs
 - c. Firefighting operations impacts on single exit stair and having appropriate width so not to impede exiting of occupants.
 - d. Rescue windows – Concern that secondary means of egress needed due to firefighting impediments and location of rescue windows limitations.
 - e. Some Fire Depts firefighting tactics align with high-rise at 4 stories.
 - 2. Recruiting additional members to join this sub-workgroup.
 - a. Chief Sujeski
 - i. Chief Berlant for further outreach to Cal Chiefs leadership.
 - ii. Cal Stats – Mike Morlan can be a reference for statistical data for items that may be relevant such as incidents or injuries.

 - i. R. Marshall - Probably not, since the lead, Tim Spears has taken another position
- B. E. Mendoza – Have we considered removing/prohibiting trash rooms?
 - i. Ali Fattah – I don't recall these buildings having trash rooms due to size. No necessary against trash rooms as they provide a place for proper disposal of trash.

- ii. S. Smith – Supports no trash room, would encourage trash to be removed from building a placed curbside for pickup.
- C. R Marshall – Elected to be added to the FD capabilities sub-work group.
- D. Ali Fattah- Building Code Comparison – Next step should include researching the ICC proposals to identify if CA should be more restrictive or less based on what is being approved.
