3. NEW BUSINESS Sujeski

- A. History-Travis Tyler summarized the history of 2005 Code Comparison project when existing fire alarm CA amendments from the UFC were blended into the IFC during the adoption of the ICC as Model code.
 - i. CFC 907 Example Modernization that duplicate CA amendment language. One potential goal of the work group could be to analyze CFC Section 907 to confirm necessary amendments.
 - ii. Chief Andersen direction to the Fire Alarm Advisory Committee, per a letter dated August 13, 2024, was to form a Fire Alarm work group to create proposals to make NFPA 72 and the California Fire Code (CFC) consistent. The correlation between the CFC and NFPA 72 would create clear guidelines for the industry and the AHJ's. (Tyler)
