



Course Reciprocity Instructions

Overview

The State Fire Training (SFT) recognizes courses offered by other agencies and institutions as reciprocal to similar courses offered through SFT.

When SFT determines that a non-SFT course is reciprocal to a similar SFT course(s), an applicant who has completed the non-SFT course may obtain an SFT course completion diploma(s) for the SFT course(s) without having to complete the SFT course(s).

Approved Reciprocal Courses

Application Process

1. Applicant mails the Course Reciprocity Application, supporting documentation, and fee(s) to: State Fire Training, Course Reciprocity, PO Box 944246, Sacramento, CA 94244-2460.
2. State Fire Training conducts an application review.
 - If the applicant does not meet the eligibility requirements, SFT issues a denial.
 - If the applicant meets the eligibility requirements, SFT issues the digital course diploma(s) through the applicant's SFT User Portal.
