



NFPA Professional Qualifications Reciprocity Instructions

Overview

The National Fire Protection Association (NFPA) Professional Qualifications Reciprocity Application is for applicants who have an IFSAC and/or Pro Board accredited certification and are seeking California course reciprocity. Certifications not bearing the appropriate seals shall not be considered.

The NFPA Professional Qualifications Reciprocity allows successful applicants to use the course reciprocity to meet the initiation requirements for [California Fire Service Training and Education System \(CFSTES\)](#) Certification Task Books, which are required to be initiated by a California Fire Agency. Additional courses and certification requirements may be required prior to being eligible for California Certification. **For some course reciprocities, applicants are required to have all levels of certifications indicated and may also be required to complete additional State Fire Training courses prior to issuance of the reciprocal course diploma.**

The California Office of the State Fire Marshal only has certification reciprocity for California Fire Fighter 1 (Fire Fighter 1, Hazardous Materials Awareness/Operations, and Wildland Fire Fighter 1) and Fire Fighter 2. Course Reciprocity Requirements

Submit verification of the following documents along with this application form. It is not necessary to submit SFT course diplomas or certifications if it is listed in your SFT User Portal. Some reciprocal NFPA Professional Qualification(s) require an additional California State Fire Training (SFT) course to be completed, prior to SFT issues course reciprocity.

Application Process

1. Applicant mails the NFPA Professional Qualifications Reciprocity Application, supporting documentation, and fee(s) to: State Fire Training, Course Reciprocity, PO Box 944246, Sacramento, CA 94244-2460.
2. State Fire Training conducts an application review.
 - If the applicant does not meet the eligibility requirements, SFT issues a denial.
 - If the applicant meets the eligibility requirements, SFT issues the digital course diploma(s) through the applicant's SFT User Portal.
