

S-212: Wildland Fire Chainsaws (2012)

Course Plan

Course Details

Description: This is an instructor-led course intended to be presented at the local level.

The course lessons provide introduction to the function, maintenance and use of internal combustion engine powered chainsaws, and their tactical wildland fire application. Field exercises support entry level training for firefighters with little or no previous experience in operating a chainsaw, providing hands-on cutting experience in surroundings similar to fireline

situations.

Designed For: Individuals desiring to be qualified as Basic Faller (FAL3), completed SFT

Firefighter 2 training, Incident Commander Type 5 (ICT5), or Felling Boss,

Single Resource (FELB).

Prerequisites: Completed SFT Firefighter 1 training. Satisfactory completion of pre-

course work.

Time Table Key

- 1. The Time Table documents the amount of time required to deliver the content included in the course plan.
