Emergency Vehicle Technician 1 Application

Overview

California Office of the State Fire Marshal Emergency Vehicle Technician (EVT) 1 Certification is based on the NFPA 1071: Emergency Vehicle Technician I Professional Qualifications set by the National Fire Protection Association (NFPA).

Applicants for initial certification use Option A and Applicants for recertification use Option B.

Certification Requirements (Option A)

Submit verification of the following documents along with this application form. It is not necessary to submit SFT course diplomas or certifications if it is listed in your SFT User Portal.

Education

- Emergency Vehicle Technician 1A: Emergency Vehicle Systems: Chassis, Cab, Body, Tank and Accessories (2020); or Preventative Maintenance (CFMA) or Knowing Your Apparatus (CFMA)
- Emergency Vehicle Technician 1B: Electrical Systems A or Electrical A (CFMA) or Electrical 1 (CFMA)
- Emergency Vehicle Technician 1C: Pumps and Accessories; or Fire Mechanic I: Fire Pumps and Accessories (SFT)

Certification Exam

• Emergency Vehicle Technician 1 Certification Exam (delivered through California Fire Mechanics Academy, Inc.), issued within five (5) years from date of application

Experience

- Have a minimum of two (2) years full-time, paid experience in a California fire department, public
 agency, or private industry as an automotive or truck mechanic, with one (1) year of which must
 be related to the maintenance of emergency response vehicles; or
- Have a minimum of three (3) years full-time, paid experience in a California fire department, public agency, or private industry as a truck mechanic with no emergency response vehicles required; or
- Have a minimum of four (4) years volunteer time or paid part-time, paid experience in a
 California fire department, public agency, or private industry as a truck mechanic with primary
 duties performing as a truck mechanic.

Fee

• \$100 non-refundable EVT 1 certification fee - payable to: State Fire Training

Recertification Requirements (Option B)

Persons with EVT 1 Certification are required to renew their certification every five (5) years. The recertification requires that the applicant completes 100 hours of approved continuing education (CE) and meet all the prerequisites stated in Recertification Requirements (Option B). All recertification applications must be postmarked on or before the certification expiration date. If the certified EVT 1 did not meet all recertification requirements by the expiration date, the EVT 1 Certification is considered to be expired.

If the EVT 1 Certification expired, the applicant will be required to complete 100 hours of CE in addition to the completion of additional CE hours. If the certification expired less than six (6) months, the applicant can regain EVT 1 Certification by completing an additional eight (8) hours of approved CE. If the certification expired between six (6) months and less than 12 months, the applicant can regain EVT 1 Certification by completing an additional 16 hours of approved CE. If the certification expired between 12 months and less than 18 months, the applicant can regain EVT 1 Certification by completing an additional 24 hours of approved CE. For expiration, greater than 18 months, the applicant will need to reapply for initial EVT 1 certification which includes successful completion of the EVT certification exam and completion of a new Certification Task Book.

• Emergency Vehicle Technician 1 Recertification Exam (delivered through CA Fire Mechanics Academy) (May only be used for (one) 1 recertification period)

Continuing Education

• A minimum of 100 hours of CA Fire Mechanics Academy approved continuing education (within five (5) years of attaining Emergency Vehicle Technician 1 certification)

Fee

• \$100 non-refundable EVT 1 recertification fee - payable to: State Fire Training

Application Process

The following are the steps for submitting certification application:

- 1. Mail the certification application, certification task book, supporting documentation, and fee to: State Fire Training, EVT 1 Certification/Recertification, PO Box 944246, Sacramento, CA 94244-2460.
- 2. SFT conducts an application review.
 - a. If the candidate does not meet the eligibility requirements, SFT issues a denial.
- 3. SFT will issue your digital certification(s) through the SFT User Portal at: https://osfm-sft.acadisonline.com/
