## Fire and Emergency Services Instructor 1

### Certification Application

---

#### Overview

The California Office of the State Fire Marshal (OSFM) Fire and Emergency Services Instructor 1 Certification is based on the NFPA 1041: Standard for Fire and Emergency Services Instructor Professional Qualifications (2019) set by the National Fire Protection Association (NFPA).

The Fire and Emergency Services Instructor (FESI) Certification Application is for applicants who have completed the FESI academic training, experience requirements and certification task book. In January 2020, State Fire Training (SFT) transitioned to “open task books”. Open task books are initiated by California Fire Agencies. If a candidate is employed by an accredited college rather than a fire agency, a fire technology director or dean is the equivalent position to fulfill any role assigned to a fire chief.

#### Application Requirements

Submit verification of the following documents along with this application form. It is not necessary to submit SFT course diplomas or certifications if it is listed in your SFT User Portal.

##### Education

- Instructor 1: Instructional Methodology

##### Certification Task Book

- Fire and Emergency Services Instructor 1 Certification Task Book or Instructor 1 Certification Task Book with all applicable Task Book Updates

##### Fee

- \$100 non-refundable FESI 1 certification fee - payable to: State Fire Training

#### Application Process

The following are the steps for submitting the certification application:

1. Mail the FESI Certification Application, certification task book, and fee to: State Fire Training, Fire and Emergency Services Instructor Certification, PO Box 944246, Sacramento, CA 94244-2460
2. SFT conducts an application review.
  - a. If the applicant does not meet the eligibility requirements, SFT issues a denial.
3. SFT will issue your digital certification(s) through the SFT User Portal at:
