

CERTIFICATION APPLICATION INSTRUCTIONS Fire Apparatus Driver/Operator Wildland Fire Apparatus Certification Application

Overview

The California Office of the State Fire Marshal Fire Apparatus Driver/Operator Wildland Fire Apparatus Certification is based on the NFPA 1002: Wildland Fire Apparatus Professional Qualifications set by the National Fire Protection Association (NFPA).

In January 2020, State Fire Training (SFT) transitioned to "Open Task Books". Open Task Books are initiated by California Fire Agencies. Applicants who previously had their Task Books initiated by SFT shall use Option A. Applicants whose task books were initiated by their Fire Agency shall use Option B.

Application Requirements

Submit verification of the following documents along with this application form. It is not necessary to submit SFT course diplomas or certifications if it is listed in your SFT User Portal.

Prerequisite

Valid Class C Firefighter Endorsed or Commercial A or Commercial B driver's license

- Fire Apparatus Driver/Operator 1A (2015 or 2008 curriculum)
- Fire Apparatus Driver/Operator 1B (2015 or 2008 curriculum)
- Wildland Fire Apparatus Operations

Application Process

Option A: Task Books Initiated by SFT (prior to December 31, 2019)

The following are the steps for submitting the certification application:

- 1. Email the certification application and certification task book to the <u>SFT Staff Member</u> who processes the certification that you are applying for.
- 2. SFT conducts an application review.
 - a. If the candidate does not meet the eligibility requirements, SFT issues a denial.
- 3. SFT will issue your digital certification(s) through the SFT User Portal at: https://osfm-sft.acadisonline.com/

Option B: Task Books Initiated by Agency (after December 31, 2019)

The following are the steps for submitting certification application:

- 1. Mail the certification application, prerequisite, certification task book, and fee to: State Fire Training, Wildland Apparatus Certification, PO Box 944246, Sacramento, CA 94244-2460.
- 2. SFT conducts an application review.
 - a. If the candidate does not meet the eligibility requirements, SFT issues a denial.
- 3. SFT will issue your digital certification(s) through the SFT User Portal at: https://osfm-sft.acadisonline.com/
