11/12/21	7-2	Fixed numbering format in skill sheet 7-2: Perform Product Control. The skill sheet originally displayed 13 steps for completion when the intention was to only require 4 steps. The second step is based on selecting one of nine scenarios.
		These nine variable scenarios were being counted as a required step.
03/11/22	6-4	Three updates to 6-4: Perform Assigned Tasks at a Hazmat/WMD Incident: 1-Updated verb in Performance Measure #10 from "Describe" to "Demonstrate". 2-Added missing Performance Measure "isolate contaminated tools, equipment, and PPE". This was included in the Course Plan but was not made explicit on the skill sheet. This new skill is now #7. 3-Updated/Clarified Performance Measure #1 to now state "Choose, inspect, don, work in, and go through decontamination while wearing, and doffing approved PPE". This was included in the Course Plan and CTS but was not made explicit on the skill sheet.
