

INFORMATION BULLETIN Recognized Fire Agencies & Authorized Signers Update Form

Issued: March 2023

OVERVIEW

SFT requires authorized signers to initiate and approve Certification Task Books, in addition to signing Letters of Verification required for instructor and evaluator registration. SFT maintains a record of these authorized signers in a Recognized Fire Agency database. Based upon guidance from the Statewide Training and Education Advisory Committee (STEAC), SFT has clarified the qualifications and procedures for recognized fire agencies and authorized signers.

PROOF OF AUTHORITY

All California Fire Departments and Fire Districts must prove their authority to SFT by December 31, 2024. SFT will not accept an authorized signer from any fire department or fire agency that has not provided their proof of authority by the deadline.

Agencies must submit their proof of authority via the following steps:
